# Saturday, May 5, 2018

#### **Business Session**

The 64th Annual Convention of Georgia State Chapter of the P.E.O. Sisterhood convened at 8:40 AM, Saturday, May 4, 2019, at the Legacy Lodge, Lake Lanier Islands, Buford, Georgia.



Chapters AB, AC, AJ, BF, BG, and BO served as Hostess chapters. Deborah Smith, D, Treasurer, Georgia State Chapter, conducted the Delegate Orientation.

Music preceded the opening of convention. Guards and pages formed an honor escort for the procession of past state presidents, officers of Georgia State Chapter, member of honor, International Representative and president of Georgia State Chapter. "I've Been Working on the Railroad" was played during the processional.

The meeting was called to order by President Lynn Harwell, AR, at 8:54 AM.

Sue Arnold Ward, AF, PSP, gave the invocation. (page 76)

Melinda Garver, BA, PSP, led the Pledge of Allegiance, followed by the singing of "O Canada" and "The Star-Spangled Banner".

The president welcomed all on behalf of the Executive Board of Georgia State Chapter.

## **First Credentials Report**

The president announced that Kenny Still will serve as the official convention photographer.

President Lynn Harwell introduced Mary Elizabeth Furnald, O\AL, PSP, editor of the Georgia P.E.O. history book, <u>P.E.O. in Georgia Vol II</u>. The president stated that each Georgia chapter and other voting delegates received a copy of this book.

# **Membership Recognition**

President Lynn Harwell called forward Barbara Brandenburgh, AI, Chairman of the Membership Committee, to introduce her committee: Kathryn Sparks, AR; Mindy O'Donnell, AQ; Katie Henry, Z, Unaffiliate Coordinator and *ex officio* committee member. Barbara Brandenburgh also recognized Sharon Morton, Georgia State Organizer and committee advisor. (page 66) Barbara Brandenburgh announced a membership award. Afterward, the president granted a brief stretch break to the delegates.

President Lynn Harwell called the convention back to order.

The Past State Presidents sang a song of welcome to Sue Baker, President, International Chapter.



#### **Keynote Address by Representative of International Chapter**

The president introduced our International Representative, Sue Baker, President, International Chapter. Following her introduction which included a glimpse at her personal as well as her P.E.O. life, Sue Baker presented the keynote address, "Women are Jewels". The president thanked her for her inspiring message and for sharing her time with us during convention.

#### **Report of Nominating Committee**

Linda Shelles, BQ, PSP, Nominating Committee Chairman introduced her committee: Kathleen Blake, A; Susan Poole, I; Jenny Dedels; AP; and Chris Parkman, AG; and gave the report of the Nominating Committee by presenting the slate of officers. The next order of business was election of officers. The following slate was proposed by the Nominating Committee:

There being no further nominations from the floor, the nominations were declared closed. There being no objection, the written ballot was dispensed with and a voice vote was taken. The entire slate as presented was elected as officers of Georgia State Chapter for the ensuing year, 2019-2020.

The president announced the installation of new officers would take place Sunday morning, May 5<sup>th</sup>, during the 3<sup>rd</sup> business session of convention.

# **Election of Delegates to Convention of International Chapter**

The next business in order was the election of delegates to the Convention of International Chapter. President Lynn Harwell explained that local chapters entitled to representation have nominated delegates, each of whom were members of this convention or had been a member of a previous convention of this state chapter. There being no objection the president waived the reading of the list of nominees as printed on page 23 of the convention manual.

Secretary Nancy Burk moved that the members whose names are on the list of nominees be elected delegates from Georgia State Chapter to the 2019 Convention of International Chapter. The motion was seconded. On a voice vote, there being a majority in the affirmative, the motion carried, and the members listed were elected as delegates.

Next, President Lynn Harwell explained that in accordance with the Constitution (Part I, Article VIII, Section 8), the following past state presidents have been designated as entitled to housing and meals at the Convention of International Chapter.

#### **ADDENDUM**

At the direction of International Chapter, Georgia State Chapter is required to make the following change in the bylaws. This change requires no action by convention.

1. The process for local chapters to present proposed amendments to state bylaws must match the process required for changes to local chapter bylaws.

(page BL-14) ARTICLE XII, AMENDMENTS, Section 2. PROCEDURE will have a new sentence 2 inserted as follows:

Local chapters desiring to submit an amendment must have that proposal approved by a two-thirds vote at a regular business meeting, provided the amendment was submitted in writing at a previous regular business meeting and all absent resident members notified that a vote will be taken at the next regular business meeting.



#### **Annual Report of the Finance Committee**

In accordance with the duties defined the P.E.O. Constitution and Bylaws and Standing Rules of Georgia State Chapter, the Finance Committee submits the following report:

Meetings were held on August 4, 2018 and January 14, 2019. In attendance were the members of the Finance Committee, all members of the Georgia State Chapter Executive Board, and the Financial Data Assistant. A budget and planning meeting was held on April 13, 2019.

All committee manuals were updated and brought into compliance with the Finance Committee Retention list.

Reports of Georgia State Chapter officers and committees containing amounts of receipts and expenditures of state chapter funds have been examined.

An audit of the financial records of Georgia State Chapter was completed by the independent CPA firm of Denman & Co., LLC, West Des Moines, Iowa and found in agreement with the financial reporting of the state treasurer.

Your Georgia Executive Board and Finance Committee sisters continually guard the monies entrusted to them with great care. For 12 years the Finance Committee has not recommended a dues increase. Since 2007 the total receipt by the state per sister has remained at \$20.00. This committee recommends a dues increase be presented at Georgia State Convention in 2020.

The budget for the current P.E.O. year 2019-2020, retroactive to April 1, has been prepared after careful review of the receipts and expenditures for the past year and is submitted to the convention for adoption. The budget is in three parts:

- General Fund,
- State Convention Fund and
- International Travel Fund.

A copy of the budget and can be found on pages 38-41 of the convention program. The Finance Committee sends our sincere appreciation to the Financial Data Assistant Frances J. DeBartola, AY, PSP for her expertise, wisdom, long-term memory, and tireless devotion and dedication to Georgia State Chapter.

The Finance Committee recommends the transfer of \$15,000 from the General Fund and \$10,000 from the General Reserve Fund to the State Convention Fund. The Finance Committee also recommends transfer of \$10,890 from the General Fund and \$6,000 from the General Reserve Fund to the International Travel Fund.

#### Annual Report of the P.E.O. International Peace Scholarship Committee



#### **Annual Report of the Grouping Committee**

The Grouping Committee met October 7, 2018 in Fayetteville and conferred via email November 6, 2018. Policies and Procedures were reviewed and committee notebooks updated.

One duty of the committee is to determine the grouping of hostess chapters for the annual convention of state chapter. The chapters are grouped geographically for convenience and economy and announced at state convention for a four-year period.

Another duty of the committee is to determine the sequence of chapters eligible to send delegates to Convention of International Chapter. The chapters in the state are divided into groups of seven chapters, or major fractions thereof, and chosen in rotation by the committee. With the addition of Chapter BS, Georgia has 67 chapters and qualifies to send ten delegates to Convention of International Chapter. The new region is composed of Atlanta area chapters.

The ten geographic regions used to select chapter delegates to attend Convention of International Chapter will also be the grouping of chapters assigned to hostess state convention beginning in 2022. (Some chapters may be exempt if it has been six years or less since they have served as a hostess chapter.)

#### **Annual Report of the Membership Committee**

The Georgia State Membership Committee included Barbara Brandenburgh, AI, Chairman, Kathryn Sparks, AR, 2<sup>nd</sup> year committee member, Mindy O'Donnell, AQ, 1<sup>st</sup> year member, Katie Henry, Z, Unaffiliate Coordinator, Sharon Morton, BM, State Organizer and committee adviser and Deborah Smith, D, Treasurer and Ex-Officio member. The Committee met twice during the year and kept in contact by email and phone calls on a regular basis.

During our initial meeting in June 2018, we reviewed each member's responsibilities for the coming year, Membership pals were assigned, and the Goals and Objectives for 2018-19 were established.

Our Goals and Objectives primarily focused in two areas:

- 1. Transferring as many Georgia Unaffiliates into Georgia local chapters as possible. The primary means to accomplish this task was by encouraging each chapter to take prompt action and follow-up upon receipt of their annual Unaffiliate list. The Membership Committee's goal was to have at least 50% of the chapters contact their Unaffiliates by the specified deadline. This goal was accomplished! The local chapters deserve credit for making this a priority. It is the Committee's hope that this percentage will continue to increase.
- 2. The second goal focused on the State President's emphasis on chapter enrichment. The Membership Committee's goal was to encourage local chapters to engage in one chapter enrichment activity and include the activity in the local chapter's annual report. The goal was to achieve 80% response to this goal. This goal was accomplished! Over 90% of local chapters engaged in at least one chapter enrichment activity this past year.

Kathryn Sparks sent out congratulatory cards to 21 Reinstated members, 114 New Initiates and 4 chapters who celebrated birthday milestones.

Mindy O'Donnell distributed 22 Introductions of a Woman Who Is Not a P.E.O. in Your Area and Barbara Brandenburgh handled 25 Notices of a P.E.O. in Your Area.

It has been a pleasure working with these self-motivated and competent ladies serving on the committee. The chairman's job was made easier because the committee members readily accepted their responsibilities and adapted to changes in their work processes to accommodate changes made at the International level.

#### **Annual Report of the Unaffiliate Coordinator**

It was my pleasure to serve as the Unaffiliate Coordinator for the state of Georgia during the 2018-2019 year.

It was established that this position would organize the unaffiliate list for Georgia state Chapters and send an unaffiliate list to each chapter through the membership committee. I took each person on the unaffilate list and tried to connect them with a chapter close to their address. A

list for each chapter was compiled and sent out this fall with the request that they contact each person and updates on the unaffiliates be sent back to me by December 1st.

Chapters were quick to start working on their list! We heard back from a record-breaking 54 percent of chapters this year! When it was all said and done, the state of Georgia was able to update 154 unaffiliates in our system this year. Each year we hear back from more and more sisters, this is a 30 percent increase in responses from last year! This does not include the

many sisters that we were unable to receive a response from over three years of attempts, so they are now being removed from our list moving forward. The hope is that these sisters will one day update their information with International and we can then connect them with a Chapter in their area.

In this position, I have also had the pleasure of speaking with P.E.O.s across the United States and either update them on Sisters from their state that our Chapters found updates on or receive names from them to pass on to Chapters in Georgia.

It has truly been an honor to serve as Georgia's Unaffiliate Coordinator and help connect P.E.O.s with our wonderful Chapters across the state and the United States and Canada.

#### **Annual Report of the Georgia Scholarship Committee**

Two meetings were held during the year. The first was held on August 8, 2017, to review and revise the policies and procedures as needed. Following the document revisions, the Chairman updated the Georgia Scholarship Application Package for the website to facilitate access to this package by the Georgia Chapters who were sponsoring scholarship applicants.

Fifty-one applications were received from chapters by January 31, 2019. The committee members reviewed each application, and scored them according to key agreed upon scoring criteria.

A second meeting was held by conference call on February 25, 2019, to make decisions on how many scholarships to be awarded, to whom and how much to award each recipient. Out of fifty-one applicants, twenty-four women qualified for scholarships based on our selection criteria. On March 25, 2019, The P.E.O. Foundation released acceptance letters to the 24 scholarship

applicants. On March 26, the Committee Chairman, sent out congratulatory letter to the scholarship recipients which specified the students award amount, Georgia scholarship sources of their funds, and the amount of funds they will receive. In addition, they were provided instructions on which forms were required to access their scholarship. Additional notices were sent the nominating Chapters, announcing the awards to their nominees. Letters were also sent to applicants who did not receive an award and their sponsoring chapters.



We've welcomed new sisters – initiates and transfers, welcomed back sisters who had been inactive for a while, and, sadly, said good-bye to sisters who have transferred – both those who have moved and those who have gone on to Chapter Eternal. A year of highs and some lows – but mostly of good times of growth and sisterly love.

We celebrated birthdays, anniversaries – our own and the chapter's – births of children and grandchildren and various other accomplishments – including (and of special note) surviving Hurricane Michael! We provided food, rides, notes and emails of support for our sisters who were recovering from illness, injury, surgery or had some other need.

We raised a record amount of money to support all of our philanthropies and the International 150 Fund! A total of \$215,190.25. (We all deserve a pat on the back for that accomplishment!) And how did we raise all of that money – we sold stuff! From pecans to note cards to plants and Christmas wreaths, gently used books and Boston butts. We held garage sales, silent auctions, live auctions, accessory auctions, vacation souvenir auctions, re-gift sales and an un-rummage sale. We collected our change, worked with Belk's and Ingles to earn money, held card parties and a 5K Fun Run. And of course, the Bed & Breakfasts available through many chapters also brought in money – and, as important, extended our well-known Georgia hospitality to sisters from all over the country.

And when we weren't busy with fund-raising projects, we also had lots of fun socializing! We had regular lunches or coffees or dinners with each other. We arranged parties with our BILs – Low country boils were popular – we also had wine tasting parties, went to ball games, had a chili cook-off on the lake, a Chinese New Year celebration and a BIL "prom". One chapter even had a Magic Show put on by a BIL – the Marginally Magnificent Cranium. We took tours of the SCAD museum, the Savannah Bee Company, Gibbs Garden, the Martha Mitchell House, the Atlanta Botanical Gardens, Martin Luther King, Jrs. Home, Chick-Fil-A headquarters, SunTrust stadium, the Kennesaw Mountain National Battleground Museum and the newly re-opened Cyclorama. We went to the theater together, to Fernbank's IMAX theater, to the movies – followed by a stop at Cold Stone Creamery for ice cream! We met in book clubs and card clubs and went to the mountains for a retreat of one day or several days.

We supported the projects in other ways, too, as we looked for applicants and worked with them to complete the process of applying for loans and scholarships. Twenty-two chapters submitted applicants for the STAR scholarships and 21 for the GA State Scholarship, 16 chapters nominated applicants for PCE grants and 14 chapters nominated applicants for Scholar Awards. While ELF doesn't keep track of the number of submissions, it's worth noting that 10 ELF loans were awarded in Georgia this past year. That's outstanding! Not all of our applicants won scholarships, grants or loans – but without those efforts to find women and work with them to apply, no one would have won anything. So, keep up the good work!

Our meetings were a source of entertainment, enlightenment and enrichment – with amazingly diverse programs. We heard speakers on mental health and addiction recovery, Honor Flight, the CASA program (that's Court Appointed Special Advocates for children), container gardening, native plants, ancestry, travel tips, poetry and frogs. We learned Japanese Calligraphy and origami, the benefits of essential oils, stained glass and CPR and personal safety. We also learned a lot about each other with programs such as "my favorite kitchen"

gadget", having sisters introduce each other, and why we each said "yes" to P.E.O. One chapter used the theme of "with a song in our heart" for the year, and the program chairman paired a song with each program! That takes a lot of work!

All of our chapters took Lynn's challenge to heart as they worked to make their meetings more enriching and inviting to their sisters – sometimes even voting to change the meeting days or times to make them accessible to more of their sisters. We worked to stay in closer contact with sisters who haven't attended many meetings in the past and also endeavored to make our business meetings more efficient and timely. We initiated telephone trees and sent out newsletters, cards and notes to make sure all members knew about upcoming meetings and other events and just to remind those that weren't at a meeting that they were missed. We also worked together to enrich the lives of others. Chapters collected books for a homeless shelter, donated books to a Title 1 school, participated in the annual walk for Alzheimers', made fleece blankets for a shelter for victims of sex trafficking, developed a prayer shawl ministry, gave 150 food items to a local women's shelter, made contributions to the GA Sheriff's Home for Children and cooked for residents of the Ronald McDonald House.

In summary, I'd describe this year as one of enriching lives – our own and others. We learned and grew in our knowledge; we helped and supported others and grew in our compassion; and we worked with our sisters planning social events and fund-raising activities – and in doing so, we grew in our sisterly love and caring for each other. All of our lives have truly been enriched throughout this past year.

And in a few minutes, I'll be moving to the club car to sit with three of my mentors: Rita Briggs, Melinda Garver, and Linda Shelles in the Rocking Chair Club. I worked with each of these ladies and observed upclose and personally as they modeled "how to be a gracious president."

There are many other ways that the P.E.O. past has informed its present. This is food for thought and would make a worthy exercise for a P.E.O. program!

Almost all of you embraced my challenge to set goals for enrichment of your chapters this year. Most of you have already seen progress. Don't stop now, sisters! # **Incoming President's Opening Remarks**

#### Sue Hauseman, BP

#### A Patchwork of Sisters

I want to thank you for the privilege of standing here before you as president of Georgia State Chapter. It's been an incredible 4 years from the first time I was escorted to the front to be installed as secretary – and while I can't honestly say I've loved every minute of it – I can say that I have thoroughly enjoyed almost all of this time – and especially the opportunity to meet and get to know so many of my sisters around the state. We are an incredible group of women.

When I started thinking about what my theme would be for this year, what first came to mind was you – all of the wonderful sisters we have here in Georgia. We are all so different in many respects – yet we have this wonderful bond of sisterhood that ties us all together.

How are we different? Just look around you – we're different physically – some tall, some short – some "just right". Some very thin, some like me who are just "under tall" for our weight. Some of us are physically fit – maybe even marathon runners or tri-athletes! – others of us have enough stamina to go shopping.

We live in very diverse locations – from the ocean-side to the mountains, in large cities, small towns and very rural areas. Our ages are quite diverse also – from the twenty-somethings to the ninety-somethings. Our educational achievements, careers, backgrounds are all so diverse – even our religious practices vary. We've all avowed that we believe in God, but how we practice that belief varies widely.

How could we all be so different yet share such a strong, warm bond with each other? What has brought us together – and what keeps those ties strong?

As I pondered this, I began to think about fabric and quilting. I'm a quilter – and I'll bet there are some other quilters in the audience today?

So, I can hear some of you thinking – just where is she going with this?

Think with me for a few moments as I explain the process of making a quilt. First you need fabric. Now in olden times, quilts were often made from scraps – old clothing, feed sacks, etc. – but today we have an entire industry devoted to making beautiful printed colorful fabrics specifically for quilting. The fabrics are of every possible color and



design – absolutely beautiful. So, a quilter accumulates fabrics to be used for the quilt – probably several pieces of fabric, generally some different colors – some similar, some contrasting and probably different designs, too. Flowers, geometric designs, various prints, solid colors – all very diverse – but they're going to somehow be brought together to make a





quilt. In that process, the quilter also finds fabrics that just don't' fit into this quilt. They may be beautiful colors and designs, but they won't be right for this quilt. (But we buy them anyway for another quilt sometime in the future). If we think of these fabrics as our friends and acquaintances, we understand that not all of them "fit well" together. Some of our friends are P.E.O.s, but some aren't - and that's OK.

Along with the fabric, we must also decide on a pattern – just how are we going to put these beautiful fabrics together – what style will we use. The pattern that has brought us together here is the P.E.O. sisterhood that was begun 150 years ago.



Once we have all of these, the fun begins – we start cutting the various fabrics into the shapes and sizes we'll need to make our design.







Next, we take that quilt top and some more fabric for the back of the quilt along with some stuffing – or batting as we call it – between the two layers of fabric. Then we do some more sewing – the actual quilting – that holds these three layers together. This makes the quilt warm and strengthens the quilt so it will hold up to be used.

The final step in this process is to take a bit more fabric in a long strip and sew it onto

the edges of the quilt – this is called the binding, and it holds everything together and finishes it all off.





## So, do you see the similarities here?



We individually are all beautiful pieces of fabric – various colors and designs. We've become our own color and design from our diverse backgrounds. We have a huge number of interests and commitments – but we take a piece of ourselves and give it to P.E.O. – just like we take a piece of each fabric we have to put into the quilt design.

We're sewn together into our quilt top of P.E.O. We have the backing of our International Chapter who support and guide us – and the in-between batting and support of our local and state chapters. We are sewn together in these layers with our Constitution and Bylaws and all of the support that we receive – for instance your President's book – think about how that supports your chapter in running meetings and handling any kind of event that occurs in your chapter. Those stitches of support hold all of our local, state and International chapters together and make us strong.





So, what's the binding in this patchwork quilt of sisters? I believe it's the vows we've all taken at our initiation - to love and support each other in our sisterhood. I've seen so many examples of this sisterly love over the past four years in the way you all care for each other – during illness, a death in the family, or in the face of some natural disaster. We also rejoice with each other in all kinds of events – weddings, birth of grandchildren,

children's accomplishments, our own career achievements and so much more.

So, there we have it – our quilt is completed. Now, what do we do with it? Well, when some people finish quilts they may hang them on a wall to show them off. And, there certainly are quilts that need to be displayed like that – they're truly works of art and should be treated as such. Other quilts may be shown off at first, but are then tucked away in a cabinet or dresser and never displayed or used. And then there are the quilts that are used, put on a bed and keep us warm at night, maybe even the dogs cozy up on the quilt at night. Maybe the quilt is given away to a close friend or family member – someone who really appreciates the work and artistry that went into making the quilt.

#### And what about our P.E.O. quilt?

I think some of the same things happen with it. Some sisters join P.E.O. and then display that for others to see – but don't really make use of P.E.O. – their membership is something to display but not to use. Others take great pride in their P.E.O. membership at first – but then they tuck it into that drawer or display case and aren't very active in using their membership. But the best P.E.O. quilts are the ones that are used all of the time and often given away to a friend or family member – sharing the warmth and love of P.E.O. with others. That's certainly the best way for our quilt to be used.

Now the real question – how does all of this apply to me, to us?

We are all part of this sisterhood quilt – it provides warmth and comfort to all of us – but it shouldn't stop with us. We need to share this warmth with others – by inviting others to join us, by expanding our horizons to birth new chapters to grow the sisterhood in Georgia. Yesterday you heard Sharon's presentation about growing new chapters. This is something we need to actively work on. We have so many geographic regions in this state where we could easily support a new or additional chapter. We at the state level can identify them, but we can't do the work of developing those chapters – so we're asking all of you to seriously look at your chapter and at your town or county. Ask yourself those questions that Sharon posed to you – do you

have a number of sisters who have to travel too far to attend your meetings? Is there a group of sisters who can't attend your chapter's meetings because of the day or time? Is your chapter too large? Are you no longer able to meet in members' homes? Are you really not able to get to know all of the sisters in your chapter because there are just too many of you? If the answer to any of these questions is "yes", then seriously talk about the need for a new chapter. It's an exciting thing to do – just ask any of us who have participated in the birthing process!

And we also need to work with those who already are part of our quilt, but have put theirs away – those sisters who are still active (meaning they still pay their dues) but they're not participating in our chapters. We need to reach out to them to get them involved again – find ways to include them in your socials as well as your meetings. Let them know that they are missed. We can – and should – initiate new members, and encourage inactive sisters to reinstate - and many of your chapters have done a great job of that this past year. But we need to then keep everyone involved and have our "older" – or more seasoned – members come back and join in more of our activities.

One question that we always ask as part of our Official Visit records and our Board Buddy Calls is what is your chapter's average attendance for the past year. Then we look at that number as a percent of your active membership. Last year those numbers ranged from 36% to 67%, with most chapters averaging around 50%. That means that we have a large group of sisters who have P.E.O. quilts, but they're tucked away in a drawer, not being used. We need to raise our average attendance by actively pursuing our less-active members – getting them back into the warmth of our quilt. They are part of the fabric of our quilt and we want to share the strength of our quilt with them.

We are a patchwork – we are a wonderful amalgam of fabrics, designs and colors. Individually we are each a beautiful piece of fabric. Together we've made a quilt – a beautiful piece of artwork that is incredibly functional as well. And it's a magical quilt, too. Because it keeps growing even after we think it's finished! And the bigger it grows the more love and strength it provides.

I challenge you all in the coming year to find ways to share your piece of the quilt with others. Let's grow, let's get more involved, let's spread our sisterly love.

And how did that quilt turn out? Well here it is....

#### **BYLAWS OF GEORGIA STATE CHAPTER P.E.O.**

#### 2019-2020

#### Amended May 4, 2019

#### **ARTICLE 1**

#### **CONVENTION OF STATE CHAPTER**

**Section 1. TIME** The convention of the Georgia State Chapter shall be held annually in April, May or June. The date shall be determined by the executive board in consultation with the hostess chapters. In case of emergency, the executive board may change the time of the meeting.

**Section 2. FORMAL ACTION** Any item passed by convention of the state chapter which must be implemented by local chapters shall become effective immediately upon receipt of official communication.

**Section 3. CHAPTER GROUPING** The convention shall be hosted by five or more local chapters, grouped geographically for convenience and economy. Chapter grouping shall be made by the Grouping Committee and shall be announced at each convention for a four-year period.

#### **Section 4. HOSTESS CHAPTERS**

- **A.** The hostess chapters, with consent of the one who will be president of Georgia State Chapter at the time of convention, shall determine the place of convention and, in case of emergency, shall make necessary changes.
- **B.** Hostess chapters shall receive moneys in the State Convention Fund for payment of necessary expenses as determined by the executive board and Finance Committee. Such moneys shall be used for convention expenses. Unused State Convention Fund moneys shall remain in the State Convention Fund.
- **C.** The Hostess Chapter Convention Manuals, containing all pertinent information and facts in regard to plans and preparations for convention, shall be maintained on the Georgia website.
- D. Within two months following convention of the state chapter, the finance chairman for the hostess chapters shall prepare a final financial statement and budget and send electronic copies to the immediate past president, current board members and the chairman of the Finance Committee of Georgia State Chapter.

#### **ARTICLE II**

#### REPRESENTATION IN STATE CHAPTER CONVENTION

**Section 1. MEMBERS** The Convention of Georgia State Chapter shall be composed of the following members:

Executive board

Past presidents of state chapter

Resident past presidents of International Chapter

Two elected delegates for each chapter, the president being a delegate when feasible

Chairman of Amendments and Recommendations Committee

Chairman of Finance Committee

Chairman of Grouping Committee

Historian

Chairman of Membership Committee

Chairman of Nominating Committee

Chairman of Scholarship Committee

Chairman of Technology Committee

**Unaffiliate Coordinator** 

Chairman of Cottey College Committee

International Projects Committee of three members for the P.E.O. Projects (ELF, PCE, IPS, PSA, and STAR).

**Section 2. DELEGATES** At the annual election each local chapter shall elect two delegates and two alternates to the Convention of Georgia State Chapter. The first alternate shall fill the first vacancy and the second alternate shall fill the second vacancy.

**Section 3. CHAIRMEN** When the chairman of a standing committee is unable to attend convention, another member of said committee may be seated and vote in place of the chairman.

**Section 4**. **VISITORS** Each visitor must register and receive a name tag to attend any business meeting of convention of Georgia State Chapter.

#### **ARTICLE III**

#### REPRESENTATION IN INTERNATIONAL CHAPTER CONVENTION

**Section 1. MEMBERS** Representation to the Convention of International Chapter shall be as provided in the Constitution, Part I, Article II, Section I. The chapters in the state shall be divided into groups of seven chapters, or major fractions thereof, and chosen in rotation by the Grouping Committee. The changes and assignments of the new chapters shall be made by the committee. A list of chapters entitled to representation in the succeeding Convention of International Chapter shall be printed in the proceedings of the Convention of Georgia State Chapter.

**Section 2. ELECTION** In the year of Convention of International Chapter each local chapter so notified shall nominate at the annual election a delegate and an alternate, whose names shall be submitted as required by International Chapter. Nominees shall be members of convention of the state chapter or of any previous Convention of Georgia State Chapter. The names of the delegates so nominated shall be presented to the Convention of Georgia State Chapter by the secretary for election.

**Section 3. VACANCY** In case of a vacancy, the president of the state chapter shall appoint a delegate:

first, the nominee for alternate:

second, another member of the chapter entitled to representation;

third, a member of another chapter in the group;

fourth, a member of the state chapter.

**Section 4. PAST PRESIDENTS** The active past presidents shall determine which of their number shall receive housing, meals and transportation at Convention of International Chapter.

**Section 5. REPORTS** Each member of the Georgia delegation to a Convention of International Chapter receiving housing, meals and transportation shall give a personal report on convention activities to local chapters as assigned by the president of Georgia State Chapter within eight weeks after convention. Past state presidents, not receiving housing, meals and transportation may assist in giving reports. If a report cannot be given in person, a written report may be authorized by the president of the state chapter. Each delegate shall notify the state chapter president when all reports have been given.

#### **ARTICLE IV**

#### **FINANCE**

**Section 1. DUES** The annual dues of Georgia State chapter shall be forty-six dollars (\$46.00) per active member, which shall be allocated as follows:

Twenty-six dollars (\$26.00) International Chapter dues, which shall include six dollars (\$6.00) for Cottey College and twenty dollars (\$20.00) Georgia State Chapter dues.

#### Section 2. CONVENTION OF STATE CHAPTER

- **A. LOCAL CHAPTER** Each local chapter shall, before convention, pay to the Meals and Lodging Chairman of hostess chapters, the required cost of meals and lodging for two delegates.
- **B. GEORGIA STATE CHAPTER CONVENTION FUND** Georgia State Chapter shall maintain a Georgia State Chapter Convention Fund. The fund shall cover the expenses for the following:
  - 1. Georgia State Executive Board
  - 2. Standing Committee Chairman
  - 3. Ad Hoc and Special Committee Appointments (Chairman only)
  - 4. Convention Appointees
  - 5. Convention Guests/Speakers
  - 6. State Sponsored Events
  - 7. Rentals
  - 8. Printing
  - 9. Additional needs of the fund shall be reviewed and determined annually by the executive board and Finance Committee.

#### Section 3. CONVENTION OF INTERNATIONAL CHAPTER

- A. Georgia State Chapter shall pay the most economical and practical expense of transportation to convention for its president, vice president, organizer, treasurer, secretary, chapter delegates and past state presidents entitled to housing and meals. A delegate who does not accompany the state delegation shall receive, upon submission of receipts or other documentation, expenses not to exceed the proportionate amount paid for other delegates. Unusual circumstances requiring additional travel expenses will be considered and decided by the executive board.
- **B.** Each member of the Georgia delegation to a Convention of International Chapter receiving transportation expenses may also be allowed additional lodging and incidental expenses at a rate predetermined by the executive board with approval of the Finance Committee. Receipts or other documentation must be submitted within three months of convention.
- **C.** Delegates to Convention of International Chapter traveling to make reports will be allowed reimbursement as established by the executive board and Finance Committee.
- **D.** Additional convention expenses of the organizer, treasurer, and secretary may be authorized by the executive board.

**Section 4. INTERNATIONAL CHAPTER TRAVEL FUND** Georgia State Chapter shall maintain an International Travel Fund. The fund shall cover expenses for the following:

- **A.** Delegates to Convention of International Chapter including their transportation in reporting to local chapters.
- **B.** Officers attending the annual LEAD Conference.
- **C.** One trip for the LEAD Conference Heritage Tour to Mt. Pleasant during either the organizer's year or the president's year.
- **D.** Officers and chairmen attending the biennial Cottey College Seminar.
- **E.** Additional needs of the fund shall be reviewed and determined annually by the executive board and Finance Committee.

**Section 5. STATE OFFICERS** The Georgia State Chapter shall pay all necessary expenses of its officers conducting the business of the state chapter. Officers of the state chapter shall submit an itemized account of expenditures, with documented receipts attached, to the state president at each meeting of the executive board. A summary of officers' expenses shall be prepared for the Finance Committee chairman.

#### Section 6. COMMITTEES

- A. Convention Expenses Georgia State Chapter shall pay necessary state convention expenses of the chairmen of standing and special committees and all members of the International Projects Committee as authorized by the executive board, unless said chairman or committee member is a chapter delegate.
- **B.** Committee Expenses Georgia State Chapter shall pay the necessary committee expenses of all standing and special committees as authorized by the executive board. No meetings of these committees involving travel expenses shall be held without the approval of the president. All committee expense accounts shall be prepared in duplicate by the chairman, with documented receipts attached, and submitted to the president by March 10.
- **Section 7. ORGANIZATION AND OFFICIAL VISITS** Each chapter shall provide for lodging, when necessary, for the organizer or her proxy when an officer is conducting official business for that chapter.

**Section 8. LATE REPORTS** A fine of twenty-five dollars (\$25.00) shall be billed to the chapter and paid to the treasurer of the state chapter by any local chapter when:

- **A.** the annual report of the treasurer
- B. the annual report of the corresponding secretary

is not forwarded to the proper state officer, postmarked no later than March 10. The fine applies to each late report. (Refer to ARTICLE X)

Section 9. LATE YEARBOOKS, LOCAL CHAPTER BYLAWS AND STANDING RULES, AND LOCAL CHAPTER PRESIDENT'S LETTER. A fine of five dollars (\$5.00) shall be billed to the chapter and paid to the treasurer of the state chapter by any local chapter when:

- **A.** Six local chapter yearbooks are sent to the chapter's designated executive board buddy postmarked later than July 1.
- **B.** The status of local chapter bylaws and standing rules is received by the chapter's designated executive board buddy later than March 10<sup>th</sup>.
- C. The local chapter president's letter is sent to the state president after March 10<sup>th</sup>.

This applies to each individual late report and each individual late yearbook. (Refer to Article X.)

**Section 10. FISCAL YEAR AND FINANCIAL YEAR** The fiscal year of Georgia State Chapter shall be from April 1 through March 31 of the following year. At the close of the fiscal year, the books of Georgia State Chapter shall undergo a financial review by a qualified accountant or auditing committee approved by the executive board.

**Section 11. INVESTMENT OF FUNDS** The treasurer and the executive board shall be authorized to invest funds of Georgia State Chapter.

#### **ARTICLE V**

#### **OFFICERS OF STATE CHAPTER**

#### Section 1. ELIGIBILITY

- **A.** New chapters must be represented in Convention of Georgia State Chapter once before their delegates are eligible to hold a state office.
- **B.** A nominee for office on the executive board shall have been duly elected, installed and shall have served as president of a local chapter for one term.

**Section 2. SEQUENCE OF OFFICERS** The sequence of state chapter officers shall be: president, vice president, organizer, treasurer, and secretary.

#### Section 3. NOMINATION

- **A.** The president shall appoint a nominating committee of five members which shall include at least one past state president. The president shall designate the chairman.
- **B.** Recommendations for nominees may be made by a majority written ballot of the executive board, a local chapter, the Nominating Committee, or a standing committee.
- **C.** A chapter, board or standing committee wishing to recommend an eligible member for consideration shall submit her name and qualification, with the written consent to serve if elected, to the chairman of the Nominating Committee by February 15. The chosen nominees must be members of the convention at which their names are presented.
- **D.** At convention of the state chapter, the committee shall present one name for each office. Further nominations may be made from the floor preceding the elective ballot for the office. Prior to nomination all nominees shall have consented to serve if elected.

**Section 4. INSTALLATION** If installation does not take place within sixty days of the close of convention of state chapter, the office shall be declared vacant.

#### **ARTICLE VI**

#### **SPECIAL DUTIES OF STATE OFFICERS**

Section 1. PRESIDENT The duties of the president of Georgia State Chapter shall be

- **A.** To appoint, with the approval of the executive board, all state standing committees as defined in Article VII.
- **B.** To fill vacancies, with approval by the executive board, for which no other provision has been made.
- **C.** To serve as chairman of the state chapter delegation to Convention of International Chapter.

- **D.** To serve as an ex-officio member, without vote, of all state committees except the Nominating Committee.
- **E.** To coordinate the review, update, and distribution of the Hostess Chapter Convention Manuals with the assistance of the immediate past convention chairman, vice president, and immediate past state president.
- F. To appoint, with the approval of the executive board, a special committee and/or task force.

#### Section 2. VICE PRESIDENT The duties of the vice president shall be

- **A.** To serve as adviser to the Scholarship Committee, the Grouping Committee, and the Technology Committee.
- B. To serve as ex-officio member, without vote, of the Finance Committee.
- C. To receive new programs for approval and review and keep current all Program Library materials.
- **D.** To prepare a résumé of the local chapter presidents' letters to the state president and to present this résumé to the convention of state chapter.
- **E.** To serve as adviser to reciprocity groups and P.E.O. Groups and forward the reciprocity reference list to the P.E.O. Record office by the required date.

#### Section 3. ORGANIZER The duties of the organizer shall be

- **A.** To make plans and direct proxies, appointed by the president, for official visits of chapters. In consultation with the president, determine the appropriate form of visit to promote the uniformity of procedure: (a) a comprehensive official visit to a new chapter annually for its first three years and (b) all chapters on a rotation basis.
- **B.** To plan workshops for local chapter officers as directed by the executive board.
- **C.** To serve as adviser to the Membership Committee and the Unaffiliate Coordinator.
- **D.** To serve as ex-officio member, without vote, of the Finance Committee.

#### Section 4. TREASURER The duties of the treasurer shall be

- **A.** To serve as custodian of all moneys and funds of Georgia State Chapter, reporting summaries and amounts of same.
- **B.** To inform the president of the state chapter of the contributions to funds.
- C. To serve as ex-officio member of the Finance and Membership Committees without vote.
- **D.** To serve as liaison between Georgia State Chapter and the P.E.O. Foundation.

- **E.** To close the treasurer's books as of March 31 of each year and arrange to have them reviewed by a qualified accountant or auditing committee with the approval of the executive board.
- **F.** To serve as adviser to the Cottey College Committee.
- G. To maintain records of named scholarships in the Georgia Scholarship Endowment Fund.

#### **Section 5. SECRETARY** The duties of the secretary shall be

- A. To serve as Program Librarian.
- **B.** To have the proceedings of the convention of the state chapter provided within three months following the date of the meeting to those named in the Constitution, Part II, Article VIII, Section 6, and to others as authorized by the executive board of the state chapter.
- **C.** To notify the local chapters entitled to representation in Convention of International Chapter by February 1 of the year convention is held.
- **D.** To compile the memorial list for the Time of Remembrance ceremony one month prior to convention.
- **E.** To serve as adviser to the International Projects Committee.
- **F.** To serve as ex-officio member, without vote, of the Finance Committee.

**Section 6. ALL OFFICERS** Each state officer shall serve as an Executive Board Buddy for a group of local chapters within the state. The chapters assigned to each officer will remain the same for her entire tenure on the executive board. The chapters assigned to the president will transfer to the new secretary following convention. The duties of each Board Buddy include:

- **A.** To act as the first point of contact with the local chapters assigned to her.
- **B.** To perform Board Buddy Calls each fall with her chapters that are NOT receiving an official visit that year.
- C. To send out the Board Buddy Bulletin to her chapters following each executive board meeting.
- **D.** To receive all six (6) copies of the yearbooks from her Board Buddy chapters, postmarked no later than July 1 of each year.
  - If any are received after the deadline, she will notify the State Treasurer to levy a \$5 fine to the local chapter.
- **E.** To receive the notice of changes to local bylaws and standing rules from each of her chapters by March 10.
  - If any are received after the deadline, she will notify the State Treasurer to levy a \$5 fine to the local chapter.
- F. To review the bylaws of each of her Board Buddy Chapters and to provide feedback.

#### **ARTICLE VII**

#### STANDING COMMITTEES

**Section 1. NAMES** The standing committees of Georgia State Chapter shall be: Amendments and Recommendations, Finance, Grouping, Historian, International Projects, Membership, Nominating, Scholarship, Technology, Unaffiliate Coordinator, and Cottey College. Each committee shall report at the convention of state chapter.

**Section 2. POLICIES** Each committee shall have stated policies of operation which shall have the approval of the executive board.

#### Section 3. AMENDMENTS AND RECOMMENDATIONS

- **A. Appointment** The Amendments and Recommendations Committee shall consist of three members. The president shall appoint a past president of Georgia State Chapter to serve as chairman of the committee for one year. The president shall appoint one member for a two-year term
- B. Duties The duties of the Amendments and Recommendations Committee shall be:
  - 1. To receive, by November 30, proposed amendments to the state bylaws and the standing rules recommended by local chapter, standing committees of the state chapter, and the executive board.
  - 2. To send a copy of the proposed amendments and/or recommendations in proper form to local chapters, past presidents of the state chapter, the executive board and chairman of the standing committees no later than thirty days preceding Convention of Georgia State Chapter.

**Section 4. HISTORIAN** An historian shall be appointed to keep books or articles deemed worthy of historical interest, and to keep an accurate and current list of such items in the possession, and to collect and preserve data relative to the P.E.O. Sisterhood in Georgia. An assistant historian may be appointed with the approval of the executive board.

#### Section 5. FINANCE

- A. Appointment The Finance Committee shall be composed of three members, at least one of whom shall be a past president of Georgia State Chapter; each serving a three-year term; the senior member in point of service shall be chairman. All members of the state executive board shall be ex-officio members, without vote.
- **B. Duties** The duties of the Finance committee shall be as stated in the Constitution, Part II, Article IX, Section 9:
  - 1. To consult with and advise the executive board of the state chapter on financial affairs.
  - 2. To prepare and present to convention of the state chapter an annual budget of the General Fund, based on the fiscal year, April 1 through March 31. The budget shall be sent to the executive board one week prior to convention of the state chapter.

#### Section 6. GROUPING

- **A. Appointment** The Grouping Committee shall consist of three members, each serving a three-year term and at least one of whom shall be a past president of Georgia State Chapter. The senior member in point of service shall serve as chairman. The vice president shall be adviser to the committee.
- **B. Duties** The duties of the Grouping Committee shall be to determine the grouping of hostess chapters for convention of the state chapter and the sequence of chapters eligible to send delegates to Convention of International Chapter. (See Article I, Section 3 and Article III, Section 1.)

#### Section 7. SCHOLARSHIP

- A. Appointment The Scholarship Committee shall consist of three members, each serving a three-year term, the senior member in point of service shall be chairman. The vice president shall be adviser to the committee.
- **B. Duties** The duties of the Scholarship Committee shall be to receive applications, select recipients and award grants from all funds available. The committee shall announce the scholarship grants at the convention of state chapter.

#### Section 8. MEMBERSHIP COMMITTEE

- **A. Appointment** The Membership Committee shall consist of three members, each serving a three-year term, the senior member in point of service shall be chairman. The organizer shall be the adviser. The treasurer and the unaffiliate coordinator shall be ex-officio members without vote.
- **B. Duties** To further the membership goals of P.E.O. International Chapter and Georgia State Chapter by encouraging local chapter engagement in these goals; by facilitating contacts with transfers, inactives and unaffiliates and facilitating the introduction of collegiate P.E.O.s and women not P.E.O.s; by keeping local chapters informed of membership programming changes or updates; by working with the unaffiliate coordinator to assist in dissemination of lists of unaffiliated P.E.O.s to local chapters; and by assisting all areas of membership growth within Georgia State Chapter.

#### Section 9. INTERNATIONAL PROJECTS COMMITTEE

- **A. Appointment** The International Projects Committee shall consist of three members, each serving a three year term; the senior member in point of service shall be chairman. The secretary shall be adviser.
- B. Duties The duties of the International Projects Committee shall be to serve as a resource to the local chapters regarding the International Projects: P.E.O. Educational Loan Fund, P.E.O. International Peace Scholarship, P.E.O. Program for Continuing Education, P.E.O. Scholar Awards, and P.E.O. STAR Scholarship. The committee shall be responsible for these project presentations at convention of state chapter.

**Section 10. TECHNOLOGY COMMITTEE** A technology committee shall be appointed to serve as a resource to Georgia State Chapter regarding technology needs. The vice president shall be adviser to this committee.

#### Section 11. COTTEY COLLEGE COMMITTEE

- **A. Appointment** The Cottey College Committee shall consist of three members, each serving a three-year term; the senior member in point of service shall be the chairman. The treasurer shall be the adviser.
- **B. Duties** This committee will promote interest in Cottey College including the dissemination of current information, serving as a resource to local chapters and preparing the project display at convention.

#### **Section 12. NOMINATING COMMITTEE** See Article V, Section 3.

#### Section 13. UNAFFILIATE COORDINATOR

- **A. Appointment** An Unaffiliate Coordinator shall be appointed for a three-year term to prepare and distribute lists of P.E.O. members who are not affiliated with a chapter in the city or area in which they live.
- **B. Duties** The duties of the Unaffiliate Coordinator shall be as follows:
  - 1. To access the International Membership Portal to download unaffiliate information;
  - 2. To organize the information and distribute unaffiliate lists to the Membership Committee;
  - **3.** To interact with the Membership Committee to maximize the connection with unaffiliated P.E.O.s who are seeking a chapter home;
  - **4.** To provide the organizer with lists of unaffiliates who live in areas of the state where new chapters are needed;
  - **5.** To assist the organizer as needed;
  - **6.** To serve as an ex-officio member of the Membership Committee.

#### **ARTICLE VIII**

#### **ORGANIZATION AND OFFICIAL VISITS**

**Section 1. FORMATION** No organization of a new chapter shall take place during thirty days immediately preceding the opening of the convention of the state chapter unless approved by the executive board.

#### Section 2. REQUIREMENTS

- **A.** One P.E.O. may not recommend more than three charter initiates without consent of the state executive board.
- **B.** One not a P.E.O. desiring to become a charter initiate of a chapter shall be recommended by three active P.E.O.s who know her personally. The letters of recommendation shall be sent to the organizer.

**C.** One desiring to become a charter member of a chapter must attend a minimum of five preorganizational meetings.

#### Section 3. OFFICIAL VISITS TO LOCAL CHAPTERS

- **A.** Each local chapter shall have an official visit by the organizer or her proxy, according to one of the methods established by International Chapter. A full comprehensive visit will be conducted on a rotating basis as scheduled by the executive board.
- **B.** A new chapter shall have a comprehensive visit by the organizer or her proxy for the first three years and then shall be placed in the established rotation.
- **C.** The organizer, with the approval of the executive board, may schedule additional visits to provide extra attention when deemed necessary for the well-being of a chapter.
- **D.** Any chapter may request an official visit any year.

#### **ARTICLE IX**

#### **GEORGIA SCHOLARSHIP ENDOWMENT FUND**

(Held in the P.E.O. Foundation)

#### **Section 1. ESTABLISHMENT**

- **A.** The Georgia State Chapter shall establish a fund known as the Georgia Scholarship Endowment Fund to be held and administered by the P.E.O. Foundation. The fund shall consist of voluntary contributions, memorial gifts and bequests.
- **B.** Accrued interest from the fund shall be awarded annually by the Georgia State Scholarship Committee according to policies of the committee and requirements of the P.E.O. Foundation.
- **C.** The first scholarship to be awarded each year from the Georgia Scholarship Endowment Fund shall be known as the Ruth Tabor Fox Scholarship.

#### Section 2. NAMED SCHOLARSHIPS

- **A.** A named scholarship may be added to the Georgia Scholarship Endowment Fund by making a one-time minimum contribution of \$3,000.00 to the fund by February 1st.
- **B.** Once a named scholarship has been established it will be awarded annually and announced at the annual Convention of Georgia State Chapter.
- **C.** The treasurer will maintain records of named scholarships in the Georgia Scholarship Endowment Fund.

**Section 3. DISPOSITION OF FUND** If, by a three-fourths vote of two consecutive conventions of Georgia State Chapter, it is determined that the Georgia Scholarship Endowment Fund held in the P.E.O. Foundation shall be discontinued, all assets of the fund shall be applied and distributed to a qualified charitable or educational project or projects in accordance with policies of the P.E.O. Foundation. This project or projects shall be selected by a three-fourths vote of the convention taking action and discontinuing the Georgia Scholarship Endowment Fund or at the following convention of the state chapter.

# ARTICLE X SPECIAL DUTIES OF LOCAL CHAPTER OFFICERS and LOCAL CHAPTERS (See Article IV, Section 8)

#### Section 1. PRESIDENT

- **A.** It shall be the duty of each president to send a letter to the state president by the end of February, giving in detail increase or decrease in membership, average attendance, contributions to and promotion of the P.E.O. projects and other philanthropic work, program features, social activities, spirit of cooperation and interest in chapter life. A copy of this letter shall be sent to nonresident members and to resident members unable to attend meetings regularly.
- **B.** The president shall see that six chapter yearbooks are sent to the chapter's designated executive board buddy postmarked no later than July 1.

#### Section 2. CORRESPONDING SECRETARY

The annual report of the corresponding secretary shall be postmarked by March 10.

#### Section 3. RECORDING SECRETARY

- **A.** If local chapter bylaws or standing rules have been amended during the year, the recording secretary shall send one complete copy of the bylaws and standing rules to the chapter's designated executive board buddy by March 10. This copy shall be sent electronically.
- **B.** If no changes have been made during the year, the recording secretary shall indicate such in an electronic submission to the chapter's executive board buddy by March 10.

#### Section 4. TREASURER

- **A.** The treasurer shall be responsible for keeping opportunities of the P.E.O. Foundation available to the members. She shall give a brief report of the P.E.O. Foundation annually to her chapter.
- **B.** The annual report of the treasurer shall be postmarked by March 10.

#### ARTICLE XI

#### **RECIPROCITY GROUPS**

**Section 1. PURPOSE** Local chapters or their representatives, in cities with two or more chapters, may unite for one or more of the following purposes: to welcome unaffiliated P.E.O. members, to further the acquaintance of all members in the city, and to promote the projects of the Sisterhood.

**Section 2. SUPERVISION** The vice president shall serve as adviser to reciprocity groups.

#### Section 3. ORGANIZATION

- **A.** Local chapters wishing to form a reciprocity group shall send a written request signed by the president of each chapter to the vice president of Georgia State Chapter. Consent to unite shall be granted by the executive board of the state chapter.
- **B.** Provision for financing the group must be made by each local chapter, in accordance with the bylaws of the group.

**Section 4. REPORTS** Election reports shall be submitted immediately after election as required by International Chapter. The annual financial report required by International Chapter shall be submitted by March 10. The president shall send an annual report to the vice president of the state chapter by April 10.

#### **ARTICLE XII**

#### **AMENDMENTS**

**Section 1. VOTING** These bylaws may be amended by a two-thirds vote of members present and voting at any convention of Georgia State Chapter.

**Section 2. PROCEDURE** Proposed changes must be endorsed by a chapter, a standing committee, or the executive board and shall be submitted in writing to the members of the Amendments and Recommendations Committee and the president of the state chapter by November 30. Local chapters desiring to submit an amendment must have that proposal approved by a two-thirds vote at a regular business meeting, provided the amendment was submitted in writing at a previous regular business meeting and all absent resident members notified that a vote will be taken at the next regular business meeting. Proposed changes shall be distributed to those specified in Article VII, Section 3, subsection B.2 no later than thirty days preceding convention of the state chapter.

#### G. YEARBOOK DISTRIBUTION

Six chapter yearbooks shall be sent, postmarked no later than July 1, to the chapter's executive board buddy.

- **2.** Each local chapter shall be responsible for submitting any outstanding program material to the state program file under the direction of the state vice president.
- **3.** Any official letter to the local chapter(s) from a member of the executive board or a chairman of a standing committee shall be sent to the president of the state chapter for approval before a final draft is made.
- **4.** Names of deceased members of a chapter received by the secretary of the state chapter one month prior to convention of the state chapter will appear on the Memorial Roll of that convention.
- **5.** In the case of appointment of a new revolving committee, the state president shall designate chairman, second and third member.
- **6.** If a chapter chooses not to print their bylaws and standing rules in their yearbook, each member will be provided a current copy of the chapter's bylaws and standing rules.
- 7. Proposed changes must be endorsed by a chapter, a standing committee, or the executive board and shall be submitted in writing to the members of the Amendments and Recommendations Committee and the president of the state chapter by November 30. Proposed changes shall be distributed to those specified in Article VII, Section 3, subsection B.2 for consideration no later than thirty days preceding convention of the state chapter. A standing rule shall be adopted or suspended by a majority vote. A vote to suspend applies only to the meeting at which the vote is taken.
