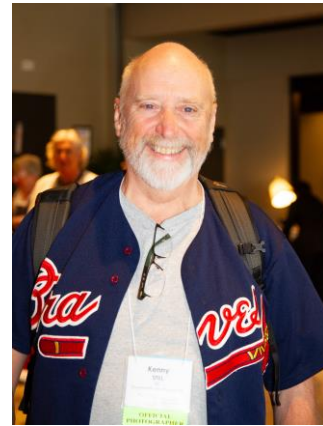

Rules of Convention

Admission

1. Admission to business meetings of convention shall be by password or by registration badge.

General

3. Music preceding each meeting has been planned for your enjoyment. Please be seated so all may enjoy it and be ready for the Call to Order.
4. Seats for business meetings are designated for past state presidents, standing committee chair, Representative of International Chapter, executive board, and chapter delegates.
5. Remain quietly seated during the processional and the recessional.
6. Those appearing on the program are to be seated in assigned seats near the floor microphone/podium prior to the time at which they are to appear.
7. A member will indicate inability to hear by raising her hand.
8. Pages are at your service to carry necessary messages, but not during devotions or keynote address, please.
9. Enter and leave the meeting only between agenda items. No one will be seated during the report of the guards or during a program.
10. A special committee appointed for this purpose will approve minutes of this convention.

11. No pictures are to be taken. Cellular phones, laptops and any other hand held and/or computer type devices are not to be used during the business of convention. Special allowances will be made for visual/hearing assistance.
12. During all business meetings, please silence all electronic devices.
13. The Time of Remembrance is a time of loving reverence. Please honor this with silence upon entering the room and during the memorial service.
14. Only gifts to the P.E.O. projects or to the Foundation may be given at this convention. Any presentation must be cleared through the convention chair and president.
15. Get acquainted with as many new sisters as you can! Share smiles often!

Speaking & Voting

16. A member of convention addressing the chair shall come to the microphone and announce her name, chapter, and city before being recognized. No member shall speak more than once or longer than two minutes on each motion without the consent of the convention.
17. Only voting members of convention may make motions, debate and vote.
18. Two signed copies of any motion from the floor shall be sent to the platform, one for the president and one for the secretary.
19. Amendments adopted at convention will take effect at the close of convention and as instructed in the Georgia State Chapter bylaws.

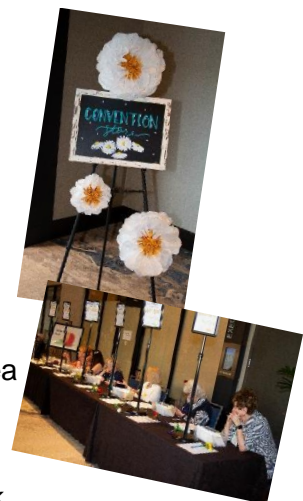

OPENING MEETING

Saturday, May 4, 2024

The 68th Annual Convention of Georgia State Chapter of the P.E.O. Sisterhood convened at 8:35 a.m. Saturday, May 4, 2024 at the Marriott Atlanta Northwest in Marietta, Georgia, Chapters R, W, AM, AP, AQ and BS served as hostesses.



Music was played during the processional for the Georgia State Chapter Executive Board, Representative of International Chapter, Member(s) of Honor and Past State Presidents.

The meeting was called to order by President Katie Henry, Chapter Z, at 8:40.

Sue Hauseman, PSP, Chapter BP, led the Pledge of Allegiance, after which she led the singing of "O Canada" and "The Star-Spangled Banner."

Report of the Guards

First Credentials Report

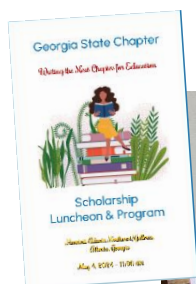

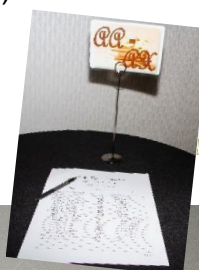

SECOND MEETING

Saturday, May 4, 2024



President Katie Henry, called the second meeting of the 68th Convention of Georgia State Chapter to order at 2:00 p.m.

Report of the Guards

The assistant guards took their places and the head guard, Jaque Henson, gave the report of the guards.

Second Credentials Report

The second report of the Credentials Committee was given by the chair, Francy DeBartola, PSP, Chapter AY, 166 members of convention were reported present. On behalf of the committee. Francy moved the report be adopted. There being a majority in the affirmative the second report was adopted. (report, pgs. 95-97)

Report of Finance Committee and Adoption of Budgets

President Katie Henry called attention to the copy of the budget provided to each member of convention. She introduced the chair of the Finance Committee, Patti Rioux, Chapter V. Patti introduced the members of her committee: Kathy Schmidt, PSP, Chapter AY; Stacie Hagan, Chapter Z, as well as the Financial Data Assistant, Francy DeBartola, PSP, Chapter AY. The chair presented the committee's report including information regarding review of accounts, study of audit, preparation of budget, and recommendation of surplus funds. (reports, pgs. 69, 81-84)

The chair moved the adoption of the report. By general consent, the vote was divided into three parts and a majority voted in favour of each of the following:

1. adoption of the 2024-25 budget
2. allocation of dues for 2024-2025 to be \$10,000 allocated to the State Convention Fund and \$6,000 to be allocated to the International Travel Fund
3. \$7,717.21 surplus funds to be transferred to state convention funds

The president stated that the adoption of the report approved the report of the treasurer.

The president thanked the members of the Finance Committee for their careful attention to the financial details of the Georgia State Chapter this past year. She announced the audit report was posted on the Georgia website.

In preparation for the presentation of amendments to the Bylaws and Standing Rules of Georgia State Chapter, the president requested all members of convention to be in their assigned seats. She instructed the convention in the procedure for presentation of amendments and voting. In accordance with the Rules of Convention, amendments adopted took effect at the close of convention and as specified in the Bylaws and Standing Rules of Georgia State Chapter.

Report of Amendments and Recommendations Committee

President Katie Henry introduced the chair of the Amendments and Recommendations (A&R) Committee, Laura E. DeMars, PSP, Chapter A. The chair introduced her committee of Soni Buckalew, Chapter AR and Nicole Rutowski, Chapter AZ. The chair presented the 2024 proposed amendments to the Bylaws of Georgia State Chapter. Page numbers refer to the 2023 Bylaws and Standing Rules of Georgia State Chapter. (report, pg. 68)

Presentation of Proposed Amendments

1. Submitted by the Finance Committee of Georgia State Chapter

(page BL-3) Amend ARTICLE IV, Section 1, paragraph 1, by striking out the words “fifty-six dollars (\$56.00)” and inserting the words “sixty-eight dollars (\$68.00)”; and in paragraph 1. subparagraph 2, by striking out the words “twenty dollars (\$20.00)” and inserting the words “thirty-two dollars (\$32.00)” so that if adopted it will read

Section 1. DUES *The annual dues of Georgia State chapter shall be sixty-eight dollars (\$68.00) per active member, which shall be allocated as follows:*

Thirty-six dollars (\$36.00) International Chapter dues, which shall include six dollars (\$6.00) for Cottey College and thirty-two dollars (\$32.00) Georgia State Chapter dues.

PROVISO: *The increase of dues to thirty-two dollars (\$32.00) for Georgia State Chapter shall be implemented in two steps; an increase of six dollars (\$6.00) to twenty-six dollars (\$26.00) for the 2025-2026 fiscal year; and an increase of six dollars (\$6.00) to thirty-two dollars (\$32.00) beginning the 2026-2027 fiscal year.*

A written ballot was taken with the following results: 162 votes cast, 108 votes necessary for adoption by two-thirds, 149 affirmative and 13 negative. The amendment was adopted.

The following six amendments were considered as a whole.

2. Submitted by the Executive Board of Georgia State Chapter

(page BL-9) Amend ARTICLE VII, Section 1, sentence 1, by striking out the word “Grouping” so that if adopted it will read:

Section 1. NAMES *The standing committees of Georgia State Chapter shall be: Amendments and Recommendations, Finance, Historian, International Projects, Membership, New Chapter Development Coordinator, Nominating, Scholarship, Technology, Unaffiliate Coordinator, and Cottey College. Each committee shall report at the convention of state chapter.*

2.A. Conforming Amendment

(page BL-10) Amend ARTICLE VII, by striking out Section 6.

NOTE: If this amendment is adopted, the subsequent sections will be renumbered to conform.

2.B. Conforming Amendment

(page BL-1) Amend ARTICLE I, Section 3, sentence 2, by striking out the words “Grouping Committee” and inserting the words “Executive Board of Georgia State Chapter.” so that if adopted it will read:

Chapter grouping shall be made by the Executive Board of Georgia State Chapter and shall be announced at each convention for a four-year period.

2.C. Conforming Amendment

(page BL-2) Amend ARTICLE III, Section 1, sentence 2, by striking out the words "Grouping Committee" and inserting the words "Executive Board of Georgia State Chapter." so that if adopted it will read:

The chapters in the state shall be divided into groups of seven chapters, or major fractions thereof, and chosen in rotation by the Executive Board of Georgia State Chapter.

2.D. Conforming Amendment

(page BL-2) Amend ARTICLE II, Section 1, by striking out the words "Chair of Grouping Committee" so that if adopted it will read:

Section 1. MEMBERS *The Convention of Georgia State Chapter shall be composed of the following members:*

Executive board

Past presidents of state chapter

Resident past presidents of International Chapter

Two elected delegates for each chapter, the president being a delegate when feasible

Chair of Amendments and Recommendations Committee

Chair of Finance Committee

Historian

...

2.E. Conforming Amendment

(page BL-7) Amend ARTICLE VI, Section 2, subsection A, by striking out the words " , the Grouping Committee," so that if adopted it will read

A. To serve as adviser to the Scholarship Committee and the Technology Committee.

The amendments were adopted by a two-thirds vote.

The following six amendments were considered as a block.

3. Submitted by the Executive Board of Georgia State Chapter

(page BL-1) Amend ARTICLE I, Section 4, subsection D, by striking out the words "finance chair" prior to the words "for the hostess chapters" and inserting the words "convention treasurer"; by striking out the words "and the" and inserting a comma; and by adding the words "and the Financial Data Assistant (FDA)" so that if adopted it will read:

D. Within two months following convention of the state chapter, the convention treasurer for the hostess chapters shall prepare a final financial statement and budget and send electronic copies to the immediate past state president, current board members, chair of the Finance Committee of Georgia State Chapter and the Financial Data Assistant (FDA).

4. Submitted by the Executive Board of Georgia State Chapter

(page BL-3) Amend ARTICLE III, by striking out Section 5 and inserting a new Section 5 so that if adopted it will read:

Section 5. REPORTS *Each member of the Georgia delegation to a Convention of International Chapter receiving housing, meals and transportation shall give an in-person, virtual, or authorized written report on convention activities within eight weeks after convention to local chapters as assigned by the Executive Board of Georgia State Chapter. Only in extenuating circumstances may a written report be authorized. All chapters are required to have a representative attend at least one presentation of the report. Each delegate shall notify the state chapter president when all reports have been given.*

5. Submitted by the Executive Board of Georgia State Chapter

(BL-4) Amend ARTICLE IV, Section 5, sentence 2, by striking out the words “to the state president at each meeting of the executive board” and inserting the words “at least quarterly and within three months of being incurred to the state president in an approved electronic format with a final expense claim submitted by March 10” so that if adopted it will read:

Officers of the state chapter shall submit an itemized account of expenditures, with documented receipts attached, at least quarterly and within three months of being incurred to the state president in an approved electronic format with a final expense claim submitted by March 10.

6. Submitted by the Executive Board of Georgia State Chapter

(BL-5) Amend ARTICLE IV, Section 6, subsection B, by striking out sentence 2 and sentence 3 and inserting a new sentence 2, sentence 3, and sentence 4 so that if adopted it will read:

B. Committee Expenses *Georgia State Chapter shall pay the necessary committee expenses of all standing and special committees as authorized by the executive board. All committee expense claims shall be prepared quarterly and within three months of being incurred by the claiming committee member on approved electronic forms, with documented receipts attached, and submitted to the committee chair for review. The chair shall forward the claims to the committee adviser who shall submit them to the president, Treasurer, and Financial Data Assistant for approval. A final expense claim, with documented receipts attached, shall be submitted by each committee member to her chair, then to her adviser by March 10.*

7. Submitted by the Executive Board of Georgia State Chapter

(page BL-8) Amend ARTICLE VI, Section 6, by striking out subsection C

NOTE: If this amendment is adopted, the subsequent subsections will be re-lettered to conform.

8. Submitted by the Executive Board of Georgia State Chapter

(page BL-15) Amend Standing Rule 4, by striking out the words “one month prior to convention of the state chapter” and inserting the words “by March 31”; and by inserting the word “year’s” following the words “Memorial Roll of that” so that if adopted it would read:

4. Names of the deceased members of a chapter received by the secretary of the state chapter by March 31 will appear on the Memorial Roll of that year's convention.

The amendments were adopted by a two-thirds vote.

Presentation of Editorial Resolution

At the direction of the A&R Committee, the A&R chair moved the adoption of the following editorial resolution:

Resolved, That the 2024 – 2025 Executive Board of Georgia State Chapter be authorized to correct article and section designations, punctuation and cross-references and to make such other technical and conforming changes as may be necessary to reflect the intent of Georgia State Chapter.

The resolution was adopted

Presentation of Addendum from the 2023 Convention of International Chapter

Since there was no objection and the addendum had been distributed and no discussion or vote required, the president announced that the addendum is a result of action taken at the 2023 Convention of International Chapter and would not be read but would be included in the convention minutes and the changes made in the next printing and posting of the state bylaws and standing rules.

ADDENDUM

The following changes are to be made in the Bylaws and Standing Rules of Georgia State Chapter in order to conform with the Constitution, Bylaws and Standing Rules of the P.E.O. Sisterhood, as amended at the 2023 Convention of International Chapter. These changes require no vote by convention.

1. Each s/p/d chapter shall increase annual dues to International Chapter from twenty-six dollars (\$26.00) to thirty-six dollars (\$36.00) with the proviso to implement the increase in two steps.

(page BL-3) ARTICLE IV, FINANCE, Section 1. DUES will now be stated as:

Section 1. DUES *The annual dues of Georgia State chapter shall be fifty-six dollars (\$56.00)¹ per active member, which shall be allocated as follows:*

Thirty-six dollars (\$36.00)¹ International Chapter dues, which shall include six dollars (\$6.00) for Cottey College and twenty dollars (\$20.00) Georgia State Chapter dues.

Allocation of Dues *The Georgia State Chapter Finance Committee shall ... by convention of the state chapter.*

¹PROVISO: *The increase of dues to International Chapter to thirty-six dollars (\$36.00) shall be implemented in two steps; an increase of five dollars (\$5.00) to thirty-one dollars (\$31.00) for the 2024-2025 fiscal year; and an increase of five dollars (\$5.00) to thirty-six dollars (\$36.00) beginning the 2025-2026 fiscal year.*

NOTE: If amendment #1 is adopted, the annual dues sent to Georgia State Chapter shall be sixty-eight dollars (\$68.00); and the amount of dues for Georgia State Chapter shall be thirty-two dollars (\$32.00).

2. Each s/p/d chapter shall remove the words “resident” and “nonresident” when reference is made to active local chapter members.

(page BL-13) ARTICLE X, SPECIAL DUTIES OF LOCAL CHAPTER OFFICERS and LOCAL CHAPTERS, Section 1. PRESIDENT, subsection A, sentence 2 will now be stated as:

A copy of this letter shall be sent to members unable to attend meetings regularly.

(page BL-14) ARTICLE XII, AMENDMENTS, Section 2. PROCEDURE, sentence 2 will now be stated as:

Local chapters desiring to submit an amendment must have that proposal approved by a two-thirds vote at a regular meeting, provided the amendment was submitted in writing at a previous regular meeting and all absent members notified that a vote will be taken at the next regular meeting.

At the direction of the Executive Board of International Chapter based on the opinion of legal counsel, the following change is to be made in the Bylaws of Georgia State Chapter. This change requires no vote by convention.

1. No s/p/d shall have provisions in their bylaws that conflict with applicable governmental laws. All s/p/d chapter bylaws shall include an article stating that the bylaws shall comply with governmental laws applicable to the operation of the s/p/d chapter.

(page BL-14) A new ARTICLE XII will be inserted in the bylaws and will be stated as:

ARTICLE XII GOVERNING LAW

These bylaws shall comply with governmental laws applicable to the operation of the state chapter.

NOTE: The subsequent article will be renumbered to conform.

Presentation of Proposed Amendment to the Constitution of the P.E.O. Sisterhood

A&R Chair Laura E. DeMars presented the proposed amendment to the Constitution of the P.E.O. Sisterhood to be considered at the Convention of International Chapter.

1. Submitted by Executive Board of Georgia State Chapter

(page 44) Amend Constitution, Part III, ARTICLE VI, MEMBERS BY INITIATION, Sec. 6—BALLOTING, by striking out paragraph 3 and inserting a new paragraph 3 so that if adopted it will read:

A favorable vote of two-thirds of the chapter members present and voting shall approve the ballot.

NOTE: If this amendment is adopted, Procedure for P.E.O. Chapter Meeting, Item of Business #13. BALLOTING, will be rewritten to conform.

A written ballot was taken with the following results: 161 votes cast, 108 votes necessary for adoption by two-thirds, 138 affirmative and 23 negative. The vote was favorable and the amendment will be presented at the 2025 Convention of International Chapter.

President Katie Henry thanked the A & R chair and committee.

Annual Report of the P.E.O. Program for Continuing Education

PCE was established in 1973 to provide need-based grants to women in the U.S. and Canada whose education has been interrupted and who find it necessary to return to school to complete a degree or certification that will improve their marketable skills for employment to support themselves and/or their families. This past year, PCE awarded \$3.4m in grants to 841 women and since its inception PCE has awarded \$75m in grants to 55,608 women. During 2024, the maximum grant amount increased to \$4,000.

During the 2023-2024 year, 11 grants were awarded for a total of \$29,900 to recipients sponsored by the following 10 Georgia chapters:

Annual Report of the P.E.O. Scholar Awards

The P.E.O. Scholar Award was established in 1991 to provide substantial merit-based awards for women of the United States and Canada who are pursuing a doctoral level degree at an accredited college or university. In 2024, the P.E.O. Scholar Award Board of Trustees announced an increase in the amount of the award from \$20,000 to \$25,000.



This year a total of 827 applications were submitted throughout the US and Canada, of which 37 came from Georgia chapters. For the 2024-2025 academic year, 100 applicants will be selected to receive awards.

Annual Report of the P.E.O. STAR Scholarship

The P.E.O. STAR Scholarship provides non-renewable \$2,500 scholarships for exceptional high school graduating women to attend an accredited postsecondary educational institution in the U.S. or Canada in their next academic year. Since its inception in 2009, \$20,035,000 has been given to over 7,000 STAR recipients.

Annual Report of the Cottey College Committee



The Committee held its first meeting this year on May 16th at Glory Days restaurant in Macon, GA. Those in attendance were Judy Hood, BR, chair, Paulette Zornig Weiner, AD; Julie Thomas, BM; and Laura Cox, BI, Georgia State Secretary and Cottey Advisor. Subsequent meetings were held quarterly via Zoom.

Laura shared that the State Board was developing a new Georgia P.E.O. Monthly Newsletter, and asking each committee to submit nuggets of information to be included. This is in-lieu of the monthly Companion Letter which we had been utilizing for communication with the local chapters since 2020. The members have rotated this task and submitted articles featuring different topics and activities at Cottey that were of particular interest to them individually. This has been very educational to us and to the local chapters.

The 2023-24 goals were established as Recruit, Support, Educate and Advertise Cottey College. We have worked diligently in these areas. She will graduate in December 2024. Alyssa Mann, was on campus for only one semester and has been taking on-line classes from her home in Macon this semester. Both girls have expressed their appreciation for the support shown to them through cards, letters, gifts and holiday cakes sent by the P.E.O. sisters around the state.

Thanks to our Advisor and first year member, we added three programs to the Georgia website which can be used in chapter meetings to help educate members about Cottey's history, both old and recent.

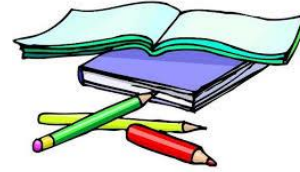

Annual Report of the Amendments & Recommendations Committee

All duties of the Amendments and Recommendations (A&R) Committee of the Georgia State Chapter (GSC) have been completed.

The business was conducted by telephone and emails and one Zoom meeting. Proposed amendments from the GSC Executive Board and the Finance committee were received by the November 30 deadline. Additionally, both the GSC Executive Board and Chapter AY sent in proposed changes to Part I of the P.E.O. Constitution. All amendments were sent to the committee members to be reviewed. The reviews were used to facilitate edits with the executive board. Those amendments pertaining to Part I of the P.E.O. Constitution were forwarded to the Chair (Judy French) and Vice Chair (Karen Leftwich) of the International Study and Research Committee.



The committee worked with S&R and the executive board to approve a final draft of the proposed changes to Part I of the P.E.O. Constitution to be sent out to all Georgia chapters for discussion and balloting to appear on the 2024 GSC Convention ballot. The committee then turned its focus to the amendments proposed by both the GSC Executive Board and the Finance committee to approve a final draft for distribution.

The proposed amendments were distributed to the local chapter presidents, PSPs, the state executive board, and state committee chairs with confirmation of receipt, printing and reading to the local chapters at regular chapter meetings. These documents were also sent to Karen Leftwich, adviser from the International Study and Research Committee (S&R), Judith French, Chair of the S&R Committee and Marty Ramsey, International Representative for the 2024 GSC Convention.

The chair would like to say a special thank you to Soni Buckalew, AR and Nicole Rutkowski, AZ for serving on the A&R Committee. Their time and talents were much appreciated.

Annual Report of the Finance Committee

In accordance with the duties defined in the P.E.O. Constitution and the Bylaws and Standing Rules of Georgia State Chapter, the Finance Committee submits the following report.



Meetings were held on August 19, 2023, and January 6, 2024. In attendance were members of the Finance Committee, the Georgia State Chapter Executive Board, and the Financial Data Assistant. A budget meeting was held on April 7, 2024.

All committee manuals were updated and brought into compliance with the Finance Committee Retention list.

Reports of Georgia State Chapter officers and committees containing amounts of receipts and expenditures of state chapter funds have been examined. An audit of the financial records of Georgia State Chapter was completed by the independent CPA firm of Denman & Co., LLC, West Des Moines, Iowa and found in agreement with the financial reporting of the state treasurer.

The budget for the current P.E.O. year, 2024-2025, retroactive to April 1, has been prepared after careful review of the receipts and expenditures for the past year and is submitted to the Convention for adoption. The committee recommends the General Fund surplus of \$7,717.21 be transferred to the State Convention Fund. The committee recommends \$10,000 be allocated to the State Convention Fund and \$6,000 be allocated to the International Travel Fund.

The committee noted the need to develop a plan for making regular contributions to the General Reserve Fund and encourages, this be a priority for consideration in 2024-2025.

The committee submitted an amendment to increase annual dues by \$12/member to be implemented in two steps, \$6.00 in the 2025-2026 dues payment and \$6.00 in the 2026-27 dues payment. The committee also recommended the Georgia State Board organize a task force to consider the effectiveness and efficiency of how our annual state convention “is done.” The Board accepted the recommendation, and the task force began meeting January 14, 2024.

Thank you to committee members Stacie Hagan, Z and Kathy Schmidt, AY, PSP who worked tirelessly throughout the year, especially while preparing the proposed amendment. We appreciate the work of Francy DeBartola, AY, PSP as our Financial Data Assistant. Francy handles the many tasks required of her with efficiency and accuracy. Her knowledge of P.E.O. at all levels is a gift to the Georgia State Chapter.

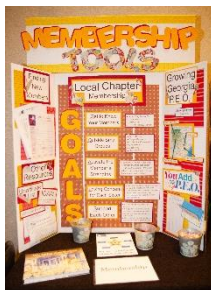

It has been a pleasure to serve as the New Chapter Development Coordinator (NCDC) this year, working closely with Peery Moran as GA State Organizer.

Efforts are underway in several areas in the state to develop new chapters. An initial meeting was held in the LaGrange area last Fall and more meetings are planned in this area this Spring. Both unaffiliate members and potential new P.E.O.s have been contacted to determine their interest in this effort.

In the Newnan area, an initial meeting will be held at the end of March to begin the process of forming an evening or weekend chapter there. This effort was originally begun in 2019, but Covid put a halt to that undertaking. Both the NCDC and the Organizer are hopeful that this new chapter process will get underway again soon.

Annual Report of the Nominating Committee

The Georgia State Chapter Bylaws and Standing Rules require the incoming president to appoint a nominating committee of five members, one of which must be a past state president. The purpose of the committee is to receive recommendations for state executive board nominees from the executive board, local chapters, the Nominating Committee or a standing committee and to prepare a slate of officers for the annual convention of the state chapter. The members of the 2023-2024 committee were Nancy Burk, BK/Athens, PSP, Chair; Chris Aiken, BB/Savannah; Nancy Davis, AF/Peachtree City; Jessica Matthews, Z/Atlanta; and Shari Ulrich, BI/Woodstock.

Commencing in June 2023 the committee utilized the state website and newsletter to promote the search for state leadership. In early October the Guidelines for Service brochure was updated and sent to all local chapters, standing committee chairs, the executive board and past state presidents. The committee's Policies and Procedures were reviewed and revised to move future commencement of the nomination process from November 1 to October 1 to accommodate local chapters who do not meet or have low attendance during the months of November and December.

In October a letter with all nomination forms was sent electronically to all local chapters, standing committee chairs, and the executive board explaining the nomination process and requesting nominations be submitted by February 15, 2024.

Committee development included an International Chapter virtual workshop for s/p/d nominating committees offered in November which all committee members attended. In December the committee members were provided past candidate interview questions to review and make revision recommendations. A final set of interview questions was approved by the committee during a virtual meeting on January 29, 2024.

Consent forms were sent to the four incumbent officers requesting permission to place their names in nomination for the next successive office. All four officers responded in the affirmative.

After the February 15, 2024, nomination deadline passed, the committee members were given nomination packets for each candidate in preparation for in-person interviews. The packets included the nomination form, recommendations and evaluations, and the candidate's information form. The candidate interviews were held in Athens, Georgia, on February 27, 2024.

Annual Report of the Georgia Scholarship Committee

This year's Georgia State Scholarship committee members are Lisa Lane, AY, Chairman, Patty Copeland, K, Second Year Member, Sally Reis, A, First Year Member, and Kathleen Blake, A, advisor. The committee would like to thank Kathleen Blake and Katie Henry for all their support during the year as we worked together to provide financial support to many wonderful students throughout the state of Georgia. We could not have been successful without your guidance.

Throughout the year, the committee held two in-person meetings and one Zoom meeting during which duties were discussed, scholarship application forms were updated, the rubric was adjusted and updated based on feedback, and the fund distribution decisions were made. There was much discussion concerning the amount to be awarded for each scholarship. In order to make the Georgia State Scholarship program more of an impact on the financial burden each student has, the committee chose to increase the amount awarded this year, thus reducing the number of scholarship recipients. Georgia State Chapter Membership Consultant

The ad hoc membership consultant was appointed at the 2023 Georgia State Convention for a one-year term charged with reviewing policies and procedures (P&Ps), reviewing what each state membership committee member does and how they do it, and ensuring that the membership practices are both effective and streamlined. The following report with additional details was submitted to the Georgia State Chapter president in January 2024 for the executive board's consideration.

A little history first:

Thirteen years ago in November 2011, the Georgia State Chapter executive board met with our then International Regional Membership Representative (RMR) Ellen Knox, PSP-TX. Also in attendance were two members of that year's membership committee. At that time, we identified five areas needing strengthening:

- Helping local chapters follow up on membership forms
- Building the relationship between chapters and their area membership committee representative
- Forming new chapters regularly
- Nurturing current members
- Encouraging reinstatements



These focus areas are still important today. Among the suggestions Ellen made during this meeting, three are still very valid today. They are:

- 1) Change the P&Ps of the membership committee so that the emphasis is less on the paper chase and more on the people.
- 2) Training is critical. The membership chair of the chapter is a vital position and the chapter doesn't have to come up with the tools.
- 3) Have a "knock 'em dead" presentation at workshops.

Research conducted:

A study of other states/provinces/districts (s/p/ds) similar in size to Georgia revealed that each s/p/d approaches their membership committee differently. None of the six-plus s/p/ds studied have had particularly stellar results growing their membership over the past years. Rather than duplicate what another s/p/d has done, I will be proposing best practices gleaned from 16 of our s/p/ds.

Interviews were conducted with former and current membership committee members, board members and Past State Presidents. Their responses showed a universal agreement that membership is extraordinarily important to the future of P.E.O. in Georgia. Many of the comments and suggestions put forth were included in my report to the Georgia president and influenced the recommendations below.

Recommendations:

- ☆ In line with the 2011 suggestion that the P&Ps of the membership committee be changed to focus less on reporting and paper pushing, it is my recommendation that we combine all membership data into one position. A possible solution follows:
Bring the number on the membership committee up to six by adding two members each year serving 3-year terms with one of the most senior duo appointed as chair. Five members would have chapter responsibilities, and the chair would take care of the Introduction of a Woman Not a P.E.O. (IOAW) and Contact Us lists. These two reports come from International quarterly and could easily be worked into her monthly work schedule. The chair would manage the lists so the information forwarded to the other members of the committee would contain only their specific chapters. She would also perform her chair duties. This idea may take a few years to implement and would require a reassignment of liaison chapters and a rewriting of the P&Ps.
- ☆ Eventually transition the New Chapter Development Coordinator (NCDC) to a 3-year assistant to the Organizer providing continuity to the Organizer position.
- ☆ By removing the paper chase from the committee members, their time could be spent working with local chapters. My suggestion is to add specifics to the P&Ps defining what the committee members do with their assigned chapters. These specifics were in the report to the Georgia president.
- ☆ The Unaffiliate Coordinator and NCDC should be voting members of the Georgia State Chapter Membership Committee and not separate standing committees. They are individual appointees and should report to the Membership Committee Chair with the Organizer continuing to serve as adviser. The NCDC also has a direct connection to the state organizer since she is initiating the development of new chapters and needs to work closely with the organizer.
- ☆ The Georgia State Membership Committee should have one voting seat at the state convention (the chair) rather than the current three votes. The cost for state conventions continues to grow and cutting two entitled (way-paid) attendees would not only help the budget but equalize representation of standing committees at convention.

I would like to thank two past presidents of Georgia, both members of Chapter AY, for their help over the past year: Kathie White, for her assistance in gathering information about other states, and Kathy Schmidt, for her knack of seeing the broader picture.

“The Rest Is Still Unwritten” Celebration

As a Media Specialist at an elementary school in Douglasville, our Georgia State President, Katie Henry (Z) chose her theme and challenged local chapters to write the next chapter in the book of Georgia P.E.O. history. She and the board have led our state chapter admirably through the “semesters” of the past year culminating with our celebration at convention. I was looking forward to our 2024 Georgia State Convention with anticipation of how Katie would conclude and celebrate her service on the state board and especially her last year as State President. Friday Afternoon – Upon check-in, chapter delegates were given their convention packets with badges, meal tickets, goodies, and a convention program. The sisterly quotes throughout the program were filled with inspiration as well as important “rules of convention” which, if followed appropriately, would definitely keep any student from having to go to the principal’s office. Only major complaint was that there were no Coca-Cola products available in the student snack bar or anywhere in the Marriott!

This was a workshop on understanding how the state’s P.E.O. monies are received and allocated in the State Financial Chapters of our book. This has been a somewhat confusing topic, so most of those present left class with a much better understanding, especially after the proposed changes to the overall budget planning and long-range benefits were explained.

One of the hottest items were the P.E.O. daisy fabric covers for canes!



The Projects “Trophy” Room was full of interesting items and display boards. It is always wonderful to be able to see what other chapters’ yearbooks look like as well as individual project displays of recipients and their sponsoring chapters. Mary Jinglewski (U) (Historian) did an excellent job with a very informative display of our Founders’ dolls and especially the first P.E.O. GA Presidents’ Book with all of those sisters’ personal signatures dating all the way back to February 16, 1935. The Cottey College display encouraged all interested sisters to



participate in a very special “duck hunt” with prizes for the lucky winners! Wish there had been some sort of display about serving on a GA State Committee. So many sisters don’t want to move to the head of the class and this sort of thing at convention might encourage interest. There was “Cocktails with Committees” one night, but there were just too many sisters trying to glean information from just a handful of committee members!



Time for happy hour! The PSP’s drifted off to their special class and dinner, while the rest of us enjoyed a “team banquet” stimulated with cocktails, wine, and beer, as well as lively conversations of chapter swapping ideas while reconnecting with old friends and making many new ones. At 7:00 pm all filled their plates with baseball hamburgers (cafeteria style) being coached to the ball game at the Projects Dinner. The PSPs came back from their teachers’ meeting and we all enjoyed dessert together. Dr. Jennifer Heflin, a current ELF recipient, told us how her ELF loan was as a major contributing factor to her endeavors as a psychologist. Michelle Wood, Vice-President for

Institutional Advancement at Cottey College and P.E.O. sister, gave a short class about “all things Cottey”. There are currently two Cottey students from Georgia. Eight Georgia State P.E.O. Scholars have been accepted for the 2024–2025 academic year. One of those students has committed to attending.



It was rumored that key teachers and administrators were going to have a “teachers’ meeting” after dinner. They gathered in the teachers’ lounge (aka Kathleen’s room) for some well-deserved celebrating while the majority of sisters just wanted to retire after a long day of travel, enthusiasm, and that afternoon “brain challenging” finance class. Everyone knew that Saturday would start early and end late with a grand celebration with all sorts of P.E.O. knowledge to be passed on in between.

Saturday Morning – As expected, morning came early with breakfast in the cafeteria at 7:00 am. The table decorations sported a parade of pencils surrounding beautiful flowering plants. And, of course, all were for sale!



Homeroom began with a grand processional of our teachers into the auditorium. Amy Pinnell (U) (IPC/ STAR Chair) gave an inspiring devotional. Sue Hausman (BP, PSP) appropriately led the “first thing in the morning” pledge of allegiance and singing of “O Canada” in honor of our Canadian sisters as well as “The Star-Spangled Banner” our own



National Anthem for the United States. All were then welcomed to school by the principal, Katie Henry. Just out of dance class, the free-flowing movements of the guards floated them down the aisles to give their report that all credentials had been checked as sisters entered the auditorium/ convention hall. There were no interlopers and all “registered” classmates were seated and in their appropriate spots.

Francy DeBartola (AY, PSP) chimed in over the loudspeaker introducing the Credentials Committee as well as giving her first report that 164 P.E.O.’s answered to “roll call” and later the attendance number would rise to 221 (including 21 GA State Scholarship recipients and their 25 family members, along with 68 guests) on class rosters. All 66 chapters in the state would be represented by two delegates throughout the entire convention. Sadly, there would be one “school dropout” as the announcement came of the disbandment of Chapter I in Macon.

As usual, the singing of the Opening Ode and reciting of the Objects and Aims by the entire student body of sisters gathered together to share their love and knowledge left good vibes and goosebumps for the entire assembly of sisters!

Marti Ramsey (BS/IN PSP, Trustee P.E.O. ELF Fund, and International Representative) gave a wonderful keynote address entitled “What’s Your Spark?”. All student sisters were inspired by what Marti had to say.



The Reports of Nominating and other standing committees were offered up. There are 2115 sisters in 66 chapters across the state of Georgia. One significant announcement brought attention to the recognition “honor” stars, which had been available for purchase prior to convention to help defray the overall cost of convention and to honor specific sisters. Their sales had generated over \$4,000! The stars were adorning multiple “lit up” Christmas trees in the auditorium behind the daisy decorated dais sporting the words “Write our Story”.



Over the past year, a total of \$303,844.88 was contributed by GA Chapters to our P.E.O. Projects, Cottey College, and the P.E.O. Foundation. There were 21 GA Chapters that contributed \$500 to each of the five projects. That information would definitely represent an “A” on their report cards! Throughout the year, Zoom formatted webinars and state leadership Monthly Newsletters were most helpful in keeping chapters well informed with the latest “school announcements”.

And then it was time to recognize our Golden Girls. There were twelve 50-year members, eleven 60-year members, six 65-year members, two 70-year members, and an amazing three 75-year members (two of them were in attendance).



Next was the GA Scholarship Luncheon where P.E.O. recipients were “Writing the Next Chapter for Education”. This year 31 young ladies received GA State Scholarships totaling \$51,200.00 in scholarship grants. Conchetta Rose Dodge (sponsored by Chapter E), recipient of the Ruth Tabor Fox Named Scholarship and Maria Zevallos-Santander (sponsored by Chapter BN),



recipient of the Ellinor O'Malley-Jean H. Lindlief Scholarship and the Garver/Heim Named Scholarship both expressed their sincere gratitude and spoke about their future plans, now financially enhanced by P.E.O. Lots of pictures were taken of these fine young women for the school yearbook.

Following lunch was the always poignantly reverent Time of Remembrance. Eighty-three sisters were honored and every sister present who knew them along with several family members were proud to be able to show their respect for these sisters who will always live on in our hearts. It was not mentioned earlier at the announcement of the disbandment of GA Chapter I, so it was a shock to learn that Chapter I had lost twelve sisters in a twelve-month period. A truly unimaginable loss! Also, Chapter Y lost ten sisters in the same time period!



Saturday Afternoon – The ringing of the bell let everyone know that it was time to return to class in the auditorium for the afternoon business session. All delegates were respectful of the proceedings and all of the business to be checked off the list before final term grades could be posted. The report of the Finance Committee presentation produced a positive, passing vote. Two paper ballots had to be taken: one was for the increase of state dues. Another was a special CIC amendment modifying the voting requirement on a ballot for membership. All other proposed amendments to the state by-laws and standing rules were adopted by hand votes. All proposed amendments passed.



We then had a seventh inning stretch. Cracker Jacks (with prizes) were passed out as “ball worthy” snacks.

BYLAWS OF GEORGIA STATE CHAPTER P.E.O.

2024-2025

Last Amended May 4, 2024

ARTICLE 1

CONVENTION OF STATE CHAPTER

Section 1. TIME and FORMAT The convention of the Georgia State Chapter shall be held annually in April, May or June. The date shall be determined by the executive board in consultation with the hostess chapters. In case of emergency, the executive board may change the time of the meeting. If determined by the executive board and approved by the Executive Board of International Chapter, the convention may be conducted through the use of internet meeting services.

Section 2. FORMAL ACTION Any item passed by convention of the state chapter which must be implemented by local chapters shall become effective immediately upon receipt of official communication.

Section 3. CHAPTER GROUPING The convention shall be hosted by five or more local chapters, grouped geographically for convenience and economy. Chapter grouping shall be made by the Executive Board of Georgia State Chapter and shall be announced at each convention for a four-year period.

Section 4. HOSTESS CHAPTERS

- A.** The hostess chapters, with consent of the one who will be president of Georgia State Chapter at the time of convention, shall determine the place/format of convention and, in case of emergency, shall make necessary changes.
- B.** Hostess chapters shall receive moneys in the State Convention Fund for payment of necessary expenses as determined by the executive board and Finance Committee. Such moneys shall be used for convention expenses. Unused State Convention Fund moneys shall remain in the State Convention Fund.
- C.** The Hostess Chapter Convention Manuals, containing all pertinent information and facts in regard to plans and preparations for convention, shall be maintained on the Georgia website.
- D.** Within two months following convention of the state chapter, the convention treasurer for the hostess chapters shall prepare a final financial statement and budget and send electronic copies to the immediate past state president, current board members, chair of the Finance Committee of Georgia State Chapter and the Financial Data Assistant (FDA).

ARTICLE II

REPRESENTATION IN STATE CHAPTER CONVENTION

Section 1. MEMBERS The Convention of Georgia State Chapter shall be composed of the following members:

- Executive board
- Past presidents of state chapter
- Resident past presidents of International Chapter
- Two elected delegates for each chapter, the president being a delegate when feasible
- Chair of Amendments and Recommendations Committee
- Chair of Finance Committee
- Historian
- Chair of Membership Committee
- New Chapter Development Coordinator
- Chair of Nominating Committee
- Chair of Scholarship Committee
- Chair of Technology Committee
- Unaffiliate Coordinator
- Chair of Cotley College Committee
- International Projects Committee of three members for the P.E.O. Projects (ELF, PCE, IPS, PSA, and STAR).

Section 2. DELEGATES At the annual election each local chapter shall elect two delegates and two alternates to the Convention of Georgia State Chapter. The first alternate shall fill the first vacancy and the second alternate shall fill the second vacancy.

Section 3. CHAIRS When the chair of a standing committee is unable to attend convention, another member of said committee may be seated and vote in place of the chair.

Section 4. VISITORS Each visitor must register and receive a name tag to attend any business meeting of convention of Georgia State Chapter.

ARTICLE III

REPRESENTATION IN INTERNATIONAL CHAPTER CONVENTION

Section 1. MEMBERS Representation to the Convention of International Chapter shall be as provided in the Constitution, Part I, Article II, Section I. The chapters in the state shall be divided into groups of seven chapters, or major fractions thereof, and chosen in rotation by the Executive Board of Georgia State Chapter. The changes and assignments of the new chapters shall be made by the committee. A list of chapters entitled to representation in the succeeding Convention of International Chapter shall be printed in the proceedings of the Convention of Georgia State Chapter.

Section 2. ELECTION In the year of Convention of International Chapter each local chapter so notified shall nominate at the annual election a delegate and an alternate, whose names shall be submitted as required by International Chapter. Nominees shall be members of convention of the state chapter or of any previous Convention of Georgia State Chapter. The names of the delegates so nominated shall be presented to the Convention of Georgia State Chapter by the secretary for election.

Section 3. VACANCY In case of a vacancy, the president of the state chapter shall appoint a delegate:

- first, the nominee for alternate;
- second, another member of the chapter entitled to representation;
- third, a member of another chapter in the group;
- fourth, a member of the state chapter.

Section 4. PAST PRESIDENTS The active past presidents shall determine which of their number shall receive housing, meals and transportation at Convention of International Chapter.

Section 5. REPORTS Each member of the Georgia delegation to a Convention of International Chapter receiving housing, meals and transportation shall give an in- person, virtual, or authorized written report on convention activities within eight weeks after convention to local chapters as assigned by the Executive Board of Georgia State Chapter. Only in extenuating circumstances may a written report be authorized. All chapters are required to have a representative attend at least one presentation of the report. Each delegate shall notify the state chapter president when all reports have been given.

ARTICLE IV

FINANCE

Section 1. DUES The annual dues of Georgia State chapter shall be sixty-eight dollars (\$68.00)^{1, 2} per active member, which shall be allocated as follows:

Thirty-six dollars (\$36.00)¹ International Chapter dues, which shall include six dollars (\$6.00) for Cotley College and thirty-two dollars (\$32.00)² Georgia State Chapter dues.

Allocation of Dues The Georgia State Chapter Finance Committee shall recommend an annual allocation of dues to state chapter funds, with the approval of the executive board, for consideration and adoption by convention of the state chapter.

¹**PROVISO:** *The increase of dues to International Chapter to thirty-six dollars (\$36.00) shall be implemented in two steps; an increase of five dollars (\$5.00) to thirty-one dollars (\$31.00) for the 2024-2025 fiscal year; and an increase of five dollars (\$5.00) to thirty-six dollars (\$36.00) beginning the 2025-2026 fiscal year.*

²**PROVISO:** *The increase of dues to thirty-two dollars (\$32.00) for Georgia State Chapter shall be implemented in two steps; an increase of six dollars (\$6.00) to twenty-six dollars (\$26.00) for the 2025-2026 fiscal year; and an increase of six dollars (\$6.00) to thirty-two dollars (\$32.00) beginning the 2026-2027 fiscal year.*

Section 2. CONVENTION OF STATE CHAPTER

- A. LOCAL CHAPTER** Each local chapter shall, before convention, pay to the Meals and Lodging Chair of hostess chapters, the required cost of meals and lodging for two delegates.

B. GEORGIA STATE CHAPTER CONVENTION FUND Georgia State Chapter shall maintain a Georgia State Chapter Convention Fund. The fund shall cover the expenses for the following:

1. Georgia State Executive Board
2. Standing Committee Chairs
3. Ad Hoc and Special Committee Appointments (Chair only)
4. Convention Appointees
5. Convention Guests/Speakers
6. State Sponsored Events
7. Rentals
8. Printing
9. Additional needs of the fund shall be reviewed and determined annually by the executive board and Finance Committee.

Section 3. CONVENTION OF INTERNATIONAL CHAPTER

- A.** Georgia State Chapter shall pay the most economical and practical expense of transportation to convention for its president, vice president, organizer, treasurer, secretary, chapter delegates and past state presidents entitled to housing and meals. A delegate who does not accompany the state delegation shall receive, upon submission of receipts or other documentation, expenses not to exceed the proportionate amount paid for other delegates. Unusual circumstances requiring additional travel expenses will be considered and decided by the executive board.
- B.** Each member of the Georgia delegation to a Convention of International Chapter receiving transportation expenses may also be allowed additional lodging and incidental expenses at a rate predetermined by the executive board with approval of the Finance Committee. Receipts or other documentation must be submitted within three months of convention.
- C.** Delegates to Convention of International Chapter traveling to make reports will be allowed reimbursement as established by the executive board and Finance Committee.
- D.** Additional convention expenses of the organizer, treasurer, and secretary may be authorized by the executive board.

Section 4. INTERNATIONAL CHAPTER TRAVEL FUND Georgia State Chapter shall maintain an International Travel Fund. The fund shall cover expenses for the following:

- A.** Delegates to Convention of International Chapter including their transportation in reporting to local chapters.
- B.** Officers attending the annual LEAD Conference.
- C.** One trip for the LEAD Conference Heritage Tour to Mt. Pleasant during either the organizer's year or the president's year.
- D.** Officers and chairs attending the biennial Cottey College Seminar.
- E.** Additional needs of the fund shall be reviewed and determined annually by the executive board and Finance Committee.

Section 5. STATE OFFICERS The Georgia State Chapter shall pay all necessary expenses of its officers conducting the business of the state chapter. Officers of the state chapter shall submit an itemized account of expenditures, with documented receipts attached, at least quarterly and within three months of being incurred to the state president in an approved electronic format with a final expense claim submitted by March 10. A summary of officers' expenses shall be prepared for the Finance Committee chair.

Section 6. COMMITTEES

- A. Convention Expenses** Georgia State Chapter shall pay necessary state convention expenses of the chairs of standing and special committees and all members of the International Projects Committee as authorized by the executive board, unless said chair or committee member is a chapter delegate.
- B. Committee Expenses** Georgia State Chapter shall pay the necessary committee expenses of all standing and special committees as authorized by the executive board. All committee expense claims shall be prepared quarterly and within three months of being incurred by the claiming committee member on approved electronic forms, with documented receipts attached, and submitted to the committee chair for review. The chair shall forward the claims to the committee adviser who shall submit them to the president, Treasurer, and Financial Data Assistant for approval. A final expense claim, with documented receipts attached, shall be submitted by each committee member to her chair, then to her adviser by March 10.

Section 7. ORGANIZATION AND OFFICIAL VISITS Each chapter shall provide for lodging, when necessary, for the organizer or her proxy when an officer is conducting official business for that chapter.

Section 8. LATE REPORTS A fine of twenty-five dollars (\$25.00) shall be billed to the chapter and paid to the treasurer of the state chapter by any local chapter when:

- A.** the annual report of the treasurer
- B.** the annual report of the corresponding secretary

is not forwarded to the proper state officer, postmarked no later than March 10. The fine applies to each late report. (Refer to ARTICLE X)

Section 9. LATE YEARBOOK, LOCAL CHAPTER BYLAWS AND STANDING RULES, AND LOCAL CHAPTER PRESIDENT'S LETTER. A fine of ten dollars (\$10.00) shall be billed to the chapter and paid to the treasurer of the state chapter by any local chapter when:

- A.** The status of local chapter bylaws and standing rules is received by the chapter's designated executive board buddy later than March 10th.
- B.** One local chapter yearbook is submitted electronically later than July 1st.
- C.** The local chapter president's letter is submitted electronically later than March 10th.

This applies to each individual late report and a late yearbook.

Section 10. FISCAL YEAR AND FINANCIAL YEAR The fiscal year of Georgia State Chapter shall be from April 1 through March 31 of the following year. At the close of the fiscal year, the books of Georgia State Chapter shall undergo a financial review by a qualified accountant or auditing committee approved by the executive board.

Section 11. INVESTMENT OF FUNDS The treasurer and the executive board shall be authorized to invest funds of Georgia State Chapter.

ARTICLE V

OFFICERS OF STATE CHAPTER

Section 1. ELIGIBILITY

- A.** New chapters must be represented in Convention of Georgia State Chapter once before their delegates are eligible to hold a state office.
- B.** A nominee for office on the executive board shall have been duly elected, installed and shall have served as president of a local chapter for one term.

Section 2. SEQUENCE OF OFFICERS The sequence of state chapter officers shall be: president, vice president, organizer, treasurer, and secretary.

Section 3. NOMINATION

- A.** The president shall appoint a nominating committee of five members which shall include at least one past state president. The president shall designate the chair.
- B.** Recommendations for nominees may be made by a majority written ballot of the executive board, a local chapter, the Nominating Committee, or a standing committee.
- C.** A chapter, board or standing committee wishing to recommend an eligible member for consideration shall submit her name and qualification, with the written consent to serve if elected, to the chair of the Nominating Committee by February 15. The chosen nominees must be members of the convention at which their names are presented.
- D.** At convention of the state chapter, the committee shall present one name for each office. Further nominations may be made from the floor preceding the elective ballot for the office. Prior to nomination all nominees shall have consented to serve if elected.

Section 4. INSTALLATION If installation does not take place within sixty days of the close of convention of state chapter, the office shall be declared vacant.

ARTICLE VI

SPECIAL DUTIES OF STATE OFFICERS

Section 1. PRESIDENT The duties of the president of Georgia State Chapter shall be

- A.** To appoint, with the approval of the executive board, all state standing committees as defined in Article VII.
- B.** To fill vacancies, with approval by the executive board, for which no other provision has been made.
- C.** To serve as chair of the state chapter delegation to Convention of International Chapter.
- D.** To serve as an ex-officio member, without vote, of all state committees except the Nominating Committee.
- E.** To coordinate the review, update, and distribution of the Hostess Chapter Convention Manuals with the assistance of the immediate past convention chair, vice president, and immediate past state president.
- F.** To appoint, with the approval of the executive board, a special committee and/or task force.

Section 2. VICE PRESIDENT The duties of the vice president shall be

- A.** To serve as adviser to the Scholarship Committee and the Technology Committee.
- B.** To serve as ex-officio member, without vote, of the Finance Committee.
- C.** To receive new programs for approval and review and keep current all Program Library materials.
- D.** To prepare a résumé of the local chapter presidents' letters to the state president and to present this résumé to the convention of state chapter.
- E.** To serve as adviser to reciprocity groups and P.E.O. Groups and forward the reciprocity reference list to the P.E.O. Record office by the required date.

Section 3. ORGANIZER The duties of the organizer shall be

- A.** To make plans and direct proxies, appointed by the president, for official visits of chapters. In consultation with the president, determine the appropriate form of visit to promote the uniformity of procedure: (a) a comprehensive official visit to a new chapter annually for its first three years and (b) all chapters on a rotation basis.
- B.** To plan workshops for local chapter officers as directed by the executive board.
- C.** To serve as adviser to the Membership Committee, the New Chapter Development Coordinator and the Unaffiliate Coordinator.
- D.** To serve as ex-officio member, without vote, of the Finance Committee.

Section 4. TREASURER The duties of the treasurer shall be

- A. To serve as custodian of all moneys and funds of Georgia State Chapter, reporting summaries and amounts of same.
- B. To inform the president of the state chapter of the contributions to funds.
- C. To serve as ex-officio member of the Finance and Membership Committees without vote.
- D. To serve as liaison between Georgia State Chapter and the P.E.O. Foundation.
- E. To close the treasurer's books as of March 31 of each year and arrange to have them reviewed by a qualified accountant or auditing committee with the approval of the executive board.
- F. To serve as adviser to the International Projects Committee.
- G. To maintain records of named scholarships in the Georgia Scholarship Endowment Fund.

Section 5. SECRETARY The duties of the secretary shall be

- A. To serve as Program Librarian.
- B. To have the proceedings of the convention of the state chapter provided within three months following the date of the meeting to those named in the Constitution, Part II, Article VIII, Section 6, and to others as authorized by the executive board of the state chapter.
- C. To notify the local chapters entitled to representation in Convention of International Chapter by February 1 of the year convention is held.
- D. To compile the memorial list for the Time of Remembrance ceremony one month prior to convention.
- E. To serve as adviser to the Cottey College Committee.
- F. To serve as ex-officio member, without vote, of the Finance Committee.
- G. To confirm receipt of all electronic yearbooks and to notify the state treasurer to levy a fine to the chapters submitting yearbooks after July 1.

Section 6. ALL OFFICERS Each state officer shall serve as an Executive Board Buddy for a group of local chapters within the state. The chapters assigned to each officer will remain the same for her entire tenure on the executive board. The chapters assigned to the president will transfer to the new secretary following convention. The duties of each Board Buddy include:

- A. To act as the first point of contact with the local chapters assigned to her.
- B. To perform Board Buddy Calls each fall with her chapters that are NOT receiving an official visit that year.

- C. To receive the notice of changes to local bylaws and standing rules from each of her chapters by March 10.
 - If any are received after the deadline, she will notify the State Treasurer to levy a \$10 fine to the local chapter.
- D. To review the bylaws of each of her Board Buddy Chapters and to provide feedback.

ARTICLE VII

STANDING COMMITTEES

Section 1. NAMES The standing committees of Georgia State Chapter shall be: Amendments and Recommendations, Finance, Historian, International Projects, Membership, New Chapter Development Coordinator, Nominating, Scholarship, Technology, Unaffiliate Coordinator, and Cotley College. Each committee shall report at the convention of state chapter.

Section 2. POLICIES Each committee shall have stated policies of operation which shall have the approval of the executive board.

Section 3. AMENDMENTS AND RECOMMENDATIONS

- A. **Appointment** The Amendments and Recommendations Committee shall consist of three members. The president shall appoint a past president of Georgia State Chapter to serve as chair of the committee for one year. The president shall appoint one member for a two-year term.
- B. **Duties** The duties of the Amendments and Recommendations Committee shall be:
 - 1. To receive, by November 30, proposed amendments to the state bylaws and the standing rules recommended by local chapter, standing committees of the state chapter, and the executive board.
 - 2. To send a copy of the proposed amendments and/or recommendations in proper form to local chapters, past presidents of the state chapter, the executive board and chair of the standing committees no later than thirty days preceding Convention of Georgia State Chapter.

Section 4. HISTORIAN A historian shall be appointed to keep books or articles deemed worthy of historical interest, and to keep an accurate and current list of such items in the possession, and to collect and preserve data relative to the P.E.O. Sisterhood in Georgia. An assistant historian may be appointed with the approval of the executive board.

Section 5. FINANCE

- A. **Appointment** The Finance Committee shall be composed of three members, at least one of whom shall be a past president of Georgia State Chapter; each serving a three-year term; the senior member in point of service shall be chair. All members of the state executive board shall be ex-officio members, without vote.

B. Duties The duties of the Finance committee shall be as stated in the Constitution, Part II, Article IX, Section 9:

1. To consult with and advise the executive board of the state chapter on financial affairs.
2. To prepare and present to convention of the state chapter an annual budget of the General Fund, based on the fiscal year, April 1 through March 31. The budget shall be sent to the executive board one week prior to convention of the state chapter.
3. To prepare and present to convention of state chapter a proposed allocation of state chapter dues.

Section 6. SCHOLARSHIP

A. Appointment The Scholarship Committee shall consist of three members, each serving a three-year term, the senior member in point of service shall be chair. The vice president shall be adviser to the committee.

B. Duties The duties of the Scholarship Committee shall be to receive applications, select recipients and award grants from all funds available. The committee shall announce the scholarship grants at the convention of state chapter.

Section 7. MEMBERSHIP COMMITTEE

A. Appointment The Membership Committee shall consist of three members, each serving a three-year term, the senior member in point of service shall be chair. The organizer shall be the adviser. The treasurer, New Chapter Development Coordinator and Unaffiliate Coordinator shall be ex-officio members without vote.

B. Duties To further the membership goals of P.E.O. International Chapter and Georgia State Chapter by encouraging local chapter engagement in these goals; by facilitating contacts with transfers, inactives and unaffiliates and facilitating the introduction of collegiate P.E.O.s and women not P.E.O.s; by keeping local chapters informed of membership programming changes or updates; by working with the unaffiliate coordinator to assist in dissemination of lists of unaffiliated P.E.O.s to local chapters; and by assisting all areas of membership growth within Georgia State Chapter.

Section 8. INTERNATIONAL PROJECTS COMMITTEE

A. Appointment The International Projects Committee shall consist of three members, each serving a three-year term; the senior member in point of service shall be chair. The treasurer shall be adviser.

B. Duties The duties of the International Projects Committee shall be to serve as a resource to the local chapters regarding the International Projects: P.E.O. Educational Loan Fund, P.E.O. International Peace Scholarship, P.E.O. Program for Continuing Education, P.E.O. Scholar Awards, and P.E.O. STAR Scholarship. The committee shall be responsible for these project presentations at convention of state chapter.

Section 9. TECHNOLOGY COMMITTEE A technology committee shall be appointed to serve as a resource to Georgia State Chapter regarding technology needs. The vice president shall be adviser to this committee.

Section 10. COTTEY COLLEGE COMMITTEE

- A. Appointment** The Cottey College Committee shall consist of three members, each serving a three-year term; the senior member in point of service shall be the chair. The secretary shall be the adviser.
- B. Duties** This committee will promote interest in Cottey College including the dissemination of current information, serving as a resource to local chapters and preparing the project display at convention.

Section 11. NOMINATING COMMITTEE See Article V, Section 3.

Section 12. UNAFFILIATE COORDINATOR

- A. Appointment** An Unaffiliate Coordinator shall be appointed for a three-year term to prepare and distribute lists of P.E.O. members who are not affiliated with a chapter in the city or area in which they live.
- B. Duties** The duties of the Unaffiliate Coordinator shall be as follows:
 - 1. To access the International Membership Portal to download unaffiliate information;
 - 2. To organize the information and distribute unaffiliate lists to the Membership Committee;
 - 3. To interact with the Membership Committee to maximize the connection with unaffiliated P.E.O.s who are seeking a chapter home;
 - 4. To provide the organizer and the New Chapter Development Coordinator with lists of unaffiliates who live in areas of the state where new chapters are needed;
 - 5. To assist the organizer as needed;
 - 6. To serve as an ex-officio member of the Membership Committee.

Section 13. NEW CHAPTER DEVELOPMENT COORDINATOR

- A. Appointment** A New Chapter Development Coordinator shall be appointed for a three-year term. The organizer will serve as adviser.
- B. Duties** The duties of the New Chapter Development Coordinator shall be to work with the organizer to identify geographical areas where new P.E.O. chapters are viable and to initiate activities to form new chapters. The New Chapter Development Coordinator shall be an ex-officio member of the Membership Committee.

ARTICLE VIII

ORGANIZATION AND OFFICIAL VISITS

Section 1. FORMATION No organization of a new chapter shall take place during thirty days immediately preceding the opening of the convention of the state chapter unless approved by the executive board.

Section 2. REQUIREMENTS One not a P.E.O. desiring to become a charter initiate of a chapter shall be recommended by three active P.E.O.s who know her personally. The letters of recommendation shall be sent to the organizer.

Section 3. OFFICIAL VISITS TO LOCAL CHAPTERS

- A.** Each local chapter shall have an official visit by the organizer or her proxy, according to one of the methods established by International Chapter. A full comprehensive visit will be conducted on a rotating basis as scheduled by the executive board.
- B.** A new chapter shall have a comprehensive visit by the organizer or her proxy for the first three years and then shall be placed in the established rotation.
- C.** The organizer, with the approval of the executive board, may schedule additional visits to provide extra attention when deemed necessary for the well-being of a chapter.
- D.** Any chapter may request an official visit any year.

ARTICLE IX

GEORGIA SCHOLARSHIP ENDOWMENT FUND

(Held in the P.E.O. Foundation)

Section 1. ESTABLISHMENT

- A.** The Georgia State Chapter shall establish a fund known as the Georgia Scholarship Endowment Fund to be held and administered by the P.E.O. Foundation. The fund shall consist of voluntary contributions, memorial gifts and bequests.
- B.** Accrued interest from the fund shall be awarded annually by the Georgia State Scholarship Committee according to policies of the committee and requirements of the P.E.O. Foundation.
- C.** The first scholarship to be awarded each year from the Georgia Scholarship Endowment Fund shall be known as the Ruth Tabor Fox Scholarship.

Section 2. NAMED SCHOLARSHIPS

- A.** A named scholarship may be added to the Georgia Scholarship Endowment Fund by making a one-time minimum contribution of \$3,000.00 to the fund by February 1st.
- B.** Once a named scholarship has been established it will be awarded annually and announced at the annual Convention of Georgia State Chapter.
- C.** The treasurer will maintain records of named scholarships in the Georgia Scholarship Endowment Fund.

Section 3. DISPOSITION OF FUND If, by a three-fourths vote of two consecutive conventions of Georgia State Chapter, it is determined that the Georgia Scholarship Endowment Fund held in the P.E.O. Foundation shall be discontinued, all assets of the fund shall be applied and distributed to a qualified charitable or educational project or projects in accordance with policies of the P.E.O. Foundation. This project or projects shall be selected by a three-fourths vote of the convention taking action and discontinuing the Georgia Scholarship Endowment Fund or at the following convention of the state chapter.

ARTICLE X SPECIAL DUTIES OF LOCAL CHAPTER OFFICERS and LOCAL CHAPTERS (See Article IV, Section 8)

Section 1. PRESIDENT

- A.** It shall be the duty of each president to send a letter to the state president electronically by March 10, giving in detail increase or decrease in membership, average attendance, contributions to and promotion of the P.E.O. projects and other philanthropic work, program features, social activities, spirit of cooperation and interest in chapter life. A copy of this letter shall be sent to members unable to attend meetings regularly.
- B.** The president shall see that a yearbook (Word or PDF) is submitted electronically as directed by the executive board no later than July 1 and that one printed yearbook is submitted in person at the Georgia State Convention.

Section 2. CORRESPONDING SECRETARY

The annual report of the corresponding secretary shall be postmarked by March 10.

Section 3. RECORDING SECRETARY

- A.** If local chapter bylaws or standing rules have been amended during the year, the recording secretary shall send one complete copy of the bylaws and standing rules to the chapter's designated executive board buddy by March 10. This copy shall be sent electronically.
- B.** If no changes have been made during the year, the recording secretary shall indicate such in an electronic submission to the chapter's executive board buddy by March 10.

Section 4. TREASURER

- A.** The treasurer shall be responsible for keeping opportunities of the P.E.O. Foundation available to the members.
- B.** The annual report of the treasurer shall be postmarked by March 10.

ARTICLE XI

RECIPROCITY GROUPS

Section 1. PURPOSE Local chapters or their representatives, in cities with two or more chapters, may unite for one or more of the following purposes: to welcome unaffiliated P.E.O. members, to further the acquaintance of all members in the city, and to promote the projects of the Sisterhood.

Section 2. SUPERVISION The vice president shall serve as adviser to reciprocity groups.

Section 3. ORGANIZATION

- A.** Local chapters wishing to form a reciprocity group shall send a written request signed by the president of each chapter to the vice president of Georgia State Chapter. Consent to unite shall be granted by the executive board of the state chapter.
- B.** Provision for financing the group must be made by each local chapter, in accordance with the bylaws of the group.

Section 4. REPORTS Election reports shall be submitted immediately after election as required by International Chapter. The annual financial report required by International Chapter shall be submitted by March 10. The president shall send an annual report to the vice president of the state chapter by April 10.

ARTICLE XII

GOVERNING LAW

These bylaws shall comply with governmental laws applicable to the operation of the state chapter.

ARTICLE XIII

AMENDMENTS

Section 1. VOTING These bylaws may be amended by a two-thirds vote of members present and voting at any convention of Georgia State Chapter.

Section 2. PROCEDURE Proposed changes must be endorsed by a chapter, a standing committee, or the executive board and shall be submitted in writing to the members of the Amendments and Recommendations Committee and the president of the state chapter by November 30. Local chapters desiring to submit an amendment must have that proposal approved by a two-thirds vote at a regular meeting, provided the amendment was submitted in writing at a previous regular meeting and all absent members notified that a vote will be taken at the next regular meeting. Proposed changes shall be distributed to those specified in Article VII, Section 3, subsection B.2 no later than thirty days preceding convention of the state chapter.

STANDING RULES OF GEORGIA STATE CHAPTER, P.E.O.

- 1.** Local Chapters shall follow the guidance for yearbook and bylaws and standing rules content and distribution as approved by the executive board and posted on the state chapter website.
- 2.** Each local chapter shall be responsible for submitting any outstanding program material to the state program file under the direction of the state vice president.
- 3.** Any official letter to the local chapter(s) from a member of the executive board or a chair of a standing committee shall be sent to the president of the state chapter for approval before a final draft is made.
- 4.** Names of the deceased members of a chapter received by the secretary of the state chapter by March 31 will appear on the Memorial Roll of that year's convention.
- 5.** In the case of appointment of a new revolving committee, the state president shall designate chair, second and third member.
- 6.** Proposed changes must be endorsed by a chapter, a standing committee, or the executive board and shall be submitted in writing to the members of the Amendments and Recommendations Committee and the president of the state chapter by November 30. Proposed changes shall be distributed to those specified in Article VII, Section 3, subsection B.2 for consideration no later than thirty days preceding convention of the state chapter. A standing rule shall be adopted or suspended by a majority vote. A vote to suspend applies only to the meeting at which the vote is taken.
